1. What are the most important achievements arising from WSIS that should be highlighted in the Zero Draft? *

The WSIS process catalyzed global awareness and dialogue on inclusive digital development, especially among governments, civil society, and the private sector.

It created foundational frameworks (e.g., the WSIS Action Lines) for digital inclusion and capacity building.

The Internet Governance Forum (IGF) has been an important platform for multistakeholder dialogue.

2. What are the most important **challenges** to the achievement of WSIS outcomes to date and in the future that need to be addressed in the Zero Draft? *

A narrow framing of digital inclusion, focused primarily on connectivity rather than trust, safety, and meaningful participation.

Lack of enforceable infrastructure to support contextual governance, cultural sovereignty, and epistemic integrity.

Emergence of generative AI systems that distort identity, context, and narrative without adequate traceability or consent.

3. What are the most important **priorities** for action to achieve the WSIS vision of a 'people-centred, inclusive and development-oriented Information Society' in the future, taking into account emerging trends? *

Embed contextual safety and trust as preconditions for inclusion.

Develop coordination-layer technologies that support plural meaning-making, consent enforcement, and cultural coherence.

Prioritize infrastructure for semantic bandwidth—knowledge graphs, traceable artifacts, trust signals, and civic overlays.

Address the risks and design challenges posed by generative AI through interoperable provenance and ethical affordances.

4. What additional themes/issues, if any, should be included in the Elements Paper? *

The emergence of a coordination layer as a new public digital substrate for sensemaking and co-governance.

The need for interface-level tools to enable cultural protocols, enforce consent, and protect marginalized worldviews.

Pluralism in epistemology and regenerative knowledge systems as priorities in digital development.

5. Do you wish to comment on particular themes/issues/paragraphs in the Elements Paper? *

The current framing of digital inclusion should be expanded to incorporate safety, trust, and cultural continuity.

The Elements Paper should explicitly recognize the governance and design implications of Al-infused information environments.

The role of public digital infrastructure in enabling collective intelligence and self-determination must be highlighted.
