The Elements Paper Paragraph 4 should be revised to include full participation by Indigenous Peoples as a priority as follows: " 4. Ensuring the full participation of developing countries and Indigenous Peoples is a priority, supported by capacity building, technology development, and financial resources." The UN Resolution on the Rights of Indigenous Peoples emphasizes in Paragraph 46 that Indigenous Peoples should have full participation of their representatives in UN meetings. This should be a priority for WSIS+20 proceedings. Please also note that the UN standard is for the term Indigenous Peoples to be capitalized in recognition of the unique identities of these people groups. How can full participation be supported? Direct consultation by the Distinguished Co-Facilitators from Albania and Kenya with the UN Special Rapporteur on Indigenous Peoples, Dr. Albert K. Barume, is recommended.
