Eddy Maloka, Chief Executive Officer, African Peer Review Mechanism



Prof. Maloka is the CEO of the African Peer Review Mechanism (APRM), an organ of the African Union responsible for promoting good governance on our continent, and a Visiting Professor at the University of Witwatersrand's School of Governance, Public and Development Management in South Africa. He was the Chairperson of the African Governance Architecture (AGA), a platform for dialogue among AU institutions with the mandate to promote good governance and strengthen democracy in Africa, and formerly the President of the Convocation of the University of Cape Town. His other previous appointments include: Special Advisor to the Minister of International Relations and Cooperation in the Republic of South Africa; South Africa's Special Representative to the Great Lakes Region; Special Advisor to the Deputy President of the Republic of South Africa;

and Advisor on Governance, Public Administration and Post-Conflict Reconstruction to the New Partnership for Africa's Development (NEPAD). Prof Maloka holds a Bachelor of Arts Degree from Rhodes University (South Africa); a Master's degree in Development Studies from the Geneva-based Institute of Development Studies, in Switzerland; and a Ph.D. in History from the University of Cape Town. He was a Post-Doctoral Fellow at Princeton University, in New Jersey, the USA; and a Research Fellow at the School of Oriental and African Studies (SOAS), the University of London. He served as President of the Association of African Political Science (AAPS), and the President of the South African Association of Political Science. He is a widely published scholar with interest in African and international affairs.

Monique Nzanzabaganwa, Deputy Chairperson of the African Union Commission









H.E. Dr. Nsanzabaganwa is the Deputy Chairperson (DCP) for the African Union Commission. She is in charge of Administration and Finance and assists the Chairperson in the execution of his functions to ensure the smooth running of the Commission and acts as the Chairperson in his absence. Dr. Nsanzabaganwa holds a Ph.D. in Economics, and Honorary Doctorate of Commerce, University of Stellenbosch. She has over twenty years' experience developing and leading programs that drive financial inclusion and economic prosperity. Prior to her election she held senior positions in the Government of the Republic of Rwanda including Minister of State in charge of Economic Planning, Minister of Trade and Industry and Deputy Governor of the Central Bank. Dr. Nsanzabaganwa has

supported various Gender Empowerment initiatives through her memberships in the Alliance for Financial Inclusion Gender committee, Women's World Banking African Advisory Council, the Graça Machel Trust Expert Group on women's financial inclusion and the digital economy in Africa, New Faces New Voices Rwanda chapter, Unity Club amongst others. Dr. Nsanzabaganwa was elected by the 34th African Union Assembly for a four-year term renewable once. She is the first woman to hold the position of Deputy Chairperson of the African Union Commission.

Navid Hanif, Assistant Secretary-General for Economic Development, UN DESA



Mr. Hanif has more than 30 years of experience in national and international Civil Service, encompassing analytical work, policymaking, programme planning, capacity development, multilateral diplomacy and extensive knowledge of the United Nations system. Prior to the Assistant Secretary-General position, Mr. Hanif was the Director of the Financing for Sustainable Development Office in the United Nations Department of Economic and Social Affairs. He was previously the Director of Office of ECOSOC Support and Coordination and prior to that was the first Head of the Strategic Planning Unit in the Office of the Under-Secretary-General. He served in the Executive Office of the Secretary-General as a member of the team for the 2005

World Summit. He also held a number of positions in the United Nations bodies, including the Vice-Chair of the High-Level Committee on Programmes. Before joining the United Nations, Mr. Hanif served in his country's Diplomatic Service, including as a delegate at its Permanent Mission to the United Nations. He holds a master's degree in International Political Economy from Columbia University, New York and a second master's degree in English Literature from Government College, Lahore.

Colleen V. Kelapile, Permanent Representative of Botswana to the United Nations, Permanent Mission of Botswana to the United Nations



H.E. Mr. Vixen Kelapile is the Permanent Representative of Botswana to the United Nations. Before his latest appointment, Mr. Kelapile was Chief of Staff to the Executive Secretary of the Addis Ababa-based United Nations Economic Commission for Africa between 2014 and 2018. From 2013 to 2014, Mr. Kelapile was the Deputy Director in the Department of Africa and the Middle East at the Ministry of Foreign Affairs and International Cooperation in Gaborone. As a member of the United Nations Advisory Committee on Administrative and Budgetary Questions beginning in 2004, he served as Vice-Chairman from 2008 to 2010 and as Chairman from 2011 until 2012. Before that, Mr. Kelapile was posted at Botswana's Permanent Mission to the United Nations in New York from 1998 to 2003, serving in a

number of positions, including First Secretary and Counsellor. He joined the foreign service in 1995. Ambassador







Kelapile joined the Ministry of International Affairs and Cooperation in 1995 as Desk Officer for the UN, soon after graduating with a bachelor's degree in Political Science and Public Administration from the University of Botswana in the same year.

Geraldine Fraser-Moleketi, Chancellor of Nelson Mandela University and Chair of the United Nations Committee of Experts on Public Administration



Mrs. Fraser-Moleketi is the Chancellor of Nelson Mandela University prior to which she was Special Envoy on Gender at the African Development Bank. In this role, she led a strategy to mainstream gender in the Bank's policies and operations, making the Bank a reference institution on gender equality in Africa. She has also served as Director of the Democratic Governance Group of UNDP with activities in more than 170 countries. Prior to joining the United Nations, Mrs. Fraser-Moleketi served in the South African Government as Minister of Public Service and Administration for two consecutive terms. She also served as Chair of the Pan African Ministers of Public Service for three consecutive terms and has worked on intergovernmental bodies globally and in Africa.

While Minister for Public Service and Administration, she served as a member of UN CEPA. As Minister for Welfare and Population Development in the first democratic Government of South Africa, she introduced the Government's white papers on social welfare (1997) and on population policy (1998) in the Parliament. She served as Deputy Minister of Welfare and coordinated the country's preparations for the Fourth World Conference on Women, held in Beijing in 1995. Mrs. Fraser-Moleketi serves on various boards across academia, government and development organizations on issues related to youth, the empowerment of women, capacity development and education, governance and poverty eradication. She is a fellow of the Institute of Politics at the Kennedy School of Harvard University, and holds a Master's degree in Administration. Mrs. Fraser-Moleketi was named 2016 New African Woman of the Year and was conferred a Doctorate of Philosophy (Honoris Causa) by the Nelson Mandela Metropolitan University, Port Elizabeth, South Africa.

Thembelani Thulas Nxesi, Acting Minister of Public Service and Administration, South Africa



Mr. Nxesi is currently serving as the Minister of Employment and Labour having previously served as the Minister of Public Works and Minister of Sport and Recreation. He holds a Bachelor of Arts degree from the University of Fort Hare obtained in 1983, a Bachelor of Education degree from Wits and a Higher Diploma in Education from UNISA. He taught at Ikusasa Senior Secondary School from 1985 to 1990. He has served as Assistant Secretary-General and Secretary-General of the South African Teacher's Union (SADTU) from 1990 to 1994 and 1994 to 2010 respectively. He was expelled from school several times for involvement in political activities.

Langton Ngorima, Director and National focal point for SDGs, Ministry of Public Service, Labour and Social Welfare, Zimbabwe









Mr. Ngorima has 25 years of service in the public service. He has served in the International Relations of the Department of the Ministry of Public Service, Labour and Social Welfare, starting as an Officer and rising through the ranks to Deputy Director in charge of the Department. He covered all matters related to labour and employment within the bilateral and multilateral sphere. Since 2018 he has been the Director for Labour Administration in the Ministry of Public Service, Labour and Social Welfare. He was appointed the National Focal person for SDGs in Zimbabwe in 2018. Mr. Ngorima has in this capacity facilitated the production of the second VNR for Zimbabwe in 2021. He further facilitated the localisation process of SDGs

leading the alignment of the National Development Plan to the SDGs. Under his leadership, Zimbabwe pioneered the process of VLRs and is in the process of cascading them to more local authorities. He was a member of the Bureau of the African Regional Forum on SDGs from 2020 -2021. Mr. Ngorima holds a Masters (Cum Laude) in Industrial and Employment Relations from University of Turin, Italy.

Ayodele Odusola, Resident Coordinator a.i., United Nations, South Africa



Mr. Odusola is the Resident Coordinator a.i for the United Nations in South Africa and Resident Representative for the UN Development Programme (UNDP). Previously, he was Chief Economist and Head of the Strategy and Analysis Team for UNDP's Regional Bureau for Africa (RBA). He is the Chair of the UNDP Corporate Technical Team on the Least Developed Countries (LDCs) and Landlocked Developing Countries (LLDCs). As an economist, Mr. Odusola focuses on dynamics of macroeconomics and development economics pertaining to the African continent. Prior to Chief Economist, he served as the RBA MDGs Adviser for Sub-Saharan Africa, after his tenure as Economic Adviser in UNDP South Africa. Before his time in South Africa, he was a Senior Economist in UNDP Nigeria,

supporting the preparation of fiscal responsibility legislation at national and state levels; coordinated fiscal policy project and expansion of tax database; local, regional and national MDGs; and human development reports as well as other knowledge products. Prior to joining the United Nations, Mr. Odusola worked with the Presidency of Nigeria (1993-2005); and from 1999 to 2005, he served as the Director of the Research and Macroeconomic Training Programme under the President's Economic Management Think-Tank. Served as Senior Consultant on fiscal policy management to several organizations like the World Bank, the West African Institute of Financial and Economic Management (WAIFEM), and the West African Monetary Institute (WAMI). Academically, Dr. Odusola has lectured several universities in Africa and has published over 50 articles in national and international journals, editing and authoring books as well as technical reports. In 2001, he was the African Visiting Scholar to the International Monetary Fund and has lectured in several universities.

Mr. Torome is the current Principal Secretary in the State Department for Planning at The National Treasury and Planning where he is providing overall co-ordinational, leadership and technical guidance on national and sectoral development planning to across Ministries, Departments and Agencies. He earlier on served as Principal Secretary in the Ministry of Defence where he was a member of the National Security Advisory Committee and Secretary to the Defence Council. Previously, he served as Principal Secretary in the State Department of Planning and Statistics in the Ministry Devolution and Planning. As an academic, he is visiting faculty at the United Nations Institute for Training and Research (UNITAR) Multilateral Diplomacy Program since 2014, and Diplo Foundation since 2007, and previously Board Member of the Institute for Diplomatic Studies and at the American University in Cairo (AUC) including the School of Global Affairs and Public Policy. As an Egyptian diplomat, his postings included Belgrade, New York, Geneva and Washington, DC. At the Foreign Ministry, he served as Deputy Assistant Foreign Minister for United Nations Affairs, member of the Cabinets of the
