I. Event Description

The National Institute of Public Administration (NIPA) of the Republic of Indonesia, in collaboration with the United Nations Department of Economic and Social Affairs (UN DESA), through its Project Office on Governance (UNPOG) of the Division for Public Institutions and Digital Government (DPIDG), and with the support of the UN Resident Coordinator Office and United Nations Development Programme (UNDP) in Indonesia_is co-organizing a Training of Trainers (TOT) Workshop on Effective National to Local Governance for Sustainable Development Goals (SDGs) Implementation in Indonesia, to be held in 11 – 13 November 2025 in Jakarta, Indonesia. The workshop is further supported by Tanoto Foundation in financial and administrative services.

The TOT Workshop comes as response to the expressed need for capacity development by NIPA in 2024. The content of the workshop is provided by UN DESA's¹ <u>Curriculum on Governance for Sustainable Development Goals</u>. The Curriculum aims to promote a critical understanding of sustainable development issues, enhance governance capacity, and strengthen public servants' awareness of their active role in contributing to achieving the SDGs.

The TOT Workshop will be conducted in a hybrid format where the participants from Indonesia will attend in person and invited speakers will virtually participate via the Zoom platform. The Workshop will be attended by 40 participants from Ministry/Agency/Local Government, 10 participants from Media, NGOs, & Academia and UN officials and other invited international experts and officials from participating countries, among others.

2. Context

The United Nations General Assembly Resolution <u>A/RES/69/327</u> emphasizes the growing need to strengthen public institutions and services at all levels supporting sustainable development. Building effective, accountable and inclusive institutions at all levels is key for the implementation of the 2030 Agenda for Sustainable Development, and Indonesia Vision 2045. The UN Secretary-General's Report, "<u>Our Common Agenda</u>"², emphasizes improving people's experience with public institutions at all levels and basic services. In his <u>special edition report on progress towards the SDGs</u>, the UN Secretary-General has urged governments to strengthen national and sub-national capacity, accountability and public institutions to deliver accelerated SDG progress. The report recognizes the central role of local and sub-national governments in implementing the SDGs, including by designing national enabling frameworks to allow sub-national governments to meet their devolved responsibilities and by strengthening their capacities and resources to advance the SDGs.³

Delivering change at the speed and scale required by the SDGs demands more than ever from public institutions and political leaders at all levels. Transparent, effective, accountable, resilient and adequately resourced institutions are the bedrock of the implementation of the 2030 Agenda. Accelerating the implementation of the 2030 Agenda is contingent upon strengthening institutions and the capacity of policymakers to design and implement inclusive, sustainable development policies and strategies. The principles of effective governance for sustainable development, developed by the UN Committee of Experts on Public Administration (CEPA) and endorsed by the United Nations Economic and Social Council (ECOSOC) in 2018, are designed to achieve this purpose: they provide guidance to transform the role of institutions and policymaking, promote new governance norms and

shift from past practices to transformative pathways that strengthen resilience and accelerate action to achieve the SDGs.

Public institutions and public servants must have the capacity and strategies to continually revisit and adjust policy implementation to maximize benefits and capitalize on synergies while understanding trade-offs and identifying feedback loops. Localization, anchored on the principle of multi-level governance and multi-stakeholder collaboration, is a key approach for greater inclusion and sustainability. Local and regional governments have a key role to play in this process since 65 percent of the SDG targets are linked to their work and mandates. As the sphere of government closest to local communities, they are essential for responding to the erosion of the social contract and for protecting our societies amid intersecting global crises.

The SDGs are institutionalized from the highest national level to subnational entities and integrated in national and subnational development planning. Indonesia's national development agenda has been aligned with the 17 Goals and 94 out of 169 measurable SDG targets. Indonesia has the 2025-2029 National Action Plan, formalizing the integration of the SDGs into the 2025-2029 National Medium Term Development Plan (RPJMN), mainstreaming 124 targets in the SDGs National Action Plan (RAN) and the Sub-national Actions Plan (RADs) localizing sustainable development at the subnational level. The National SDGs Roadmap 2030 articulates Indonesia's level of ambition for SDG achievement, prioritizing targets for over 100 SDG indicators.

Indonesia has stepped up its ambition to accelerate SDG progress at all levels of Government. Voluntary National Reviews of SDG progress was prepared in 2017, 2019, and 2021, with a further review planned for 2025.⁴ Moreover, Voluntary Local Reviews have been or are being conducted in at least 15 provinces and districts.

To ensure the mainstreaming of the SDGs at all levels of government, a Presidential Decree (2017) requires the integration of the SDGs into the national and subnational mid-term development plans, and mandates the preparation of an SDG roadmap and action plans that include clear deadlines at national, provincial, district and city levels.⁵ The integration of the SDGs into development plans is implemented at the subnational level through the Medium-Term Regional Development Plan (RPJMD) and Regional Work Plan (RKPD). SDG coordination teams have also been created at the subnational level: the involvement and role of all stakeholders at the regional level is strengthened by the establishment of the Regional Coordination Team (TKD). The involvement of municipalities/regencies in the localization of the SDGs is followed by the Ministry of Home Affairs (MoHA), responsible for decentralization policies. MoHA's regulation (2018) established Strategic Environmental Assessments (SEAs), that should define SDGs to be included in Local Mid Term Development Plans (LMDPs) of municipalities/regencies. From 2018 until 2021, about 29 provinces adopted Local Actions Plans (LAPs) aligned with SDGs. LAPs are mandatory for provinces but not for municipalities.

Despite these efforts, Indonesia faces a complex set of challenges in localizing and implementing the SDGs, marked by institutional, financial, technical, and governance constraints. According to UN Indonesia's Country Results Report 2024, the implementation of the SDGs continues to face significant challenges, particularly at the local level, due to limited institutional and technical capacity, financing gaps, and restricted fiscal autonomy. Many local governments lack the skilled personnel and resources needed to design, implement, and monitor complex programs, while disaggregated data remains insufficient for tracking progress among vulnerable groups. Engagement with youth, civil society, and marginalized communities is still inconsistent, despite promising pilot initiatives. Furthermore, regional disparities in infrastructure, income, education, and health along with limited digital access hinder inclusive development and the equitable localization of the SDGs.

At the national level, fragmented policy implementation, cross-sector coordination gaps, and evolving budget alignment mechanisms add to the complexity. Together, these factors underscore the urgent need for strengthened capacity, inclusive governance, robust regulation, and coordinated efforts to advance SDG localization and equitable development across Indonesia. Addressing these challenges aligns closely with national priorities, as one of the key pillars of Indonesia Vision 2045 is strengthening national resilience and governance, which calls for institutional and bureaucratic reforms. Bureaucratic and Institutional Reforms are strengthened to realize: the role and function of the government in achieving public interests; bureaucratic institutions that are contextual and proper in size and function; governance that is effective, inclusive, participatory, and integrated between sectors; and reliable and modern bureaucratic institution with professional civil servants that is able to manage change well. Achieving the development goals by 2045 requires comprehensive policy adjustments, better coordination among stakeholders through multi-level governance, increased investments, and enhanced capacity building to effectively implement the 2030 Agenda and Indonesia Vision 2045 at all levels of government.

3. Objectives

The TOT Workshop on "Effective National to Local Governance for SDG Implementation in Indonesia" aims to enhance the capacity of trainers and local government officials to accelerate the implementation of the 2030 Agenda and Indonesia Vision 2045. Specifically, the workshop will:

- Provide a comprehensive understanding of the SDGs and their integration into national and local policies and planning frameworks.
- Strengthen institutional capacities and coordination mechanisms to ensure effective multi-level governance for sustainable development.
- Identify and apply various innovative financing mechanisms to advance local SDG implementation
- Equip participants with tools and methodologies for reporting the SDGs.
- Foster peer learning and knowledge exchange of innovative practices and approaches to localizing the SDGs.

4. Thematic Focus

The TOT Workshop will provide a holistic and integrated framework for capacity development in governance and public institutions at the local level. The Workshop will cover the following themes, focusing on poverty reduction, education and healthcare (See Section 10. Workshop Agenda):

Multi-level Governance
Multi-stakeholder Engagement
Financing for SDG Localization
Data, Monitoring & Reporting
Condition and achievement SDGs in Indonesia

5. Methodology

The TOT Workshop will feature expert presentations, hands-on interactive activities, group discussions and innovative practices for peer-to-peer learning. The activities and group discussions will enable participants to transform in-depth learning into practice. It will be conducted in a hybrid modality. The workshop will be conducted in English, with Bahasa Indonesia interpretation to enable better communication.
