





# Project on Innovation, Digital Government Transformation and Changing Mindsets in the Caribbean SIDS

### **Overview**

The project on Developing Capacities for Innovation, Digital Government Transformation and Changing Mindsets in the Caribbean Small Island Developing States (SIDS) (DA2427J) aims to strengthen public sector national capacities for innovation, digital government transformation and changing mindsets by strengthening public servants' skills, knowledge, and understanding of the importance of public sector transformation. The beneficiary countries include The Bahamas, Barbados, and Saint Lucia. Lessons learned and experiences are being shared among countries in the Caribbean region through the project.

The Division for Public Institutions and Digital Government (DPIDG/UN DESA) is the lead entity of the project, which is working in collaboration with CARICAD, ECLAC, and the RCO's of beneficiary countries. I.Webinar Series on "Innovation, Digital Government and Changing Mindsets for Public Sector Transformation"

Online | 21 & 28 February 2024 - 20 & 27 March 2024

II.Capacity Development Workshop on Changing Mindsets for Innovation and Digital Transformation Castries, Saint Lucia | 6 August 2024 – 7 August 2024

- The first exploratory visit and capacity development workshop in the framework of this project was held, which allowed for open conversations on the gaps, challenges, and opportunities to advance an environment supportive of innovation and digital transformation in the Saint Lucian public service.

III.Capacity Development Workshop on Changing Mindsets for Innovation and Public Sector Transformation Nassau, The Bahamas | 24-26 March 2025

• On 24 March 2025, 10 Permanent Secretaries of the Government of The Bahamas learned about the

- importance of changing mindsets, the public sector transformation schema, and harnessing the potential of AI to create public value.
- Between 25-26 March 2025, 40 General Directors and senior government officials participated in a hands-on workshop, gaining knowledge and discussing The Quintet of Change and Key Mindsets and Competencies Needed for Governance Transformation, public sector schema, and adopting Al to advance digital government transformation. Participants developed action plans for changing mindsets and competencies and discussed strategies for implementation.
- 10 students from the International School of Business, Entrepreneurship and Technology (ISBET) represented the youth and joined the Workshop on 25 March.

### V.Capacity Development Workshop on Changing Mindsets for Innovation and Public Sector Transformation

Castries, Saint Lucia | 23-24 April 2025

- The workshop explored practices and approaches to support changing mindsets for innovation and digital transformation of public services. Key competencies for governance transformation, including systems thinking and strategic foresight, data and digital governance, and innovation were presented.
- The CARICAD public sector schema for innovation and its implications for public sector transformation was presented. Harnessing the potential of AI to create public value in the Caribbean, including through 'Smart Cities' was shared by ECLAC, along with a digital skills assessment.

### VI.Capacity Development Workshop on The Future of Governance: Changing Mindsets for Innovation and Public Sector Transformation Bridgetown, Barbados | 25-27 May 2025

 Over 60 Permanent Secretaries, General Directors, Senior Public Officers, CEOs and Heads of Agencies in charge of public policy implementation across the Caribbean, including Anguilla, Antigua and Barbuda, Bahamas, Barbados, Belize, British Virgin Islands, Dominica, Grenada, Guyana, Jamaica, Montserrat, Saint Lucia, St. Kitts and Nevis, St. Vincent and the Grenadines, and Trinidad and Tobago participated in the workshop.

### Vision Statement: People-Powered & Inclusive Caribbean

During the May 2025 Workshop in Barbados on "The Future of Governance: Changing Mindsets for Innovation and Public Sector Transformation," and through a strategic foresight exercise, participants proposed a collect vision statement for the Caribbean:

"Our vision is for a confident and strong Caribbean, defined by a democracy that evolves in lockstep with its people. We will build a deeply collaborative and participatory system of governance where empowered citizens and dedicated public officers work as intentional partners. The government's primary role will be to foster this partnership, creating a flexible and inclusive environment that safeguards the safety, well-being, and prosperity of all, ensuring our governance structures are fit for the future.

This people-powered democracy will be built on a foundation of unshakeable core values: transparency, accountability, equity, and social solidarity. We commit to a system that is not only responsive but also proactive, fostering progressive engagements that empower minorities and cultivate shared understanding. Through active collaboration and diplomacy, we will build a society where trust is paramount and every voice matters, creating a thriving future where empathy and collective intelligence guide our path.

The ultimate outcome of this citizen-driven approach is a resilient and unified Caribbean. By placing citizens at the heart of governance—powered by innovation and rooted in ethical leadership—we ensure that development is both sustainable and just. This vision fosters a shared responsibility for our collective future, building resilience not just in our institutions, but in every community and for every generation, creating a legacy of strength and unity."





### **Training of Trainers**

The project will organize a series of hybrid Training of Trainers in The Bahamas, Barbados, and Saint Lucia to equip the government training institutes' trainers on the use of the Curriculum on Governance for the Implementation of the Sustainable Development Goals (SDGs) toolkits (<u>Curriculum on Governance for the SDGs | Public Institutions</u>) to help them train their public servants with innovative mindsets and behaviors to better address current and future challenges related to SDG implementation.



### **Caribbean Governance Innovation Community of Practice (CoP)**

CoP brings together public servants and other stakeholders from across the region to learn from one another and turbocharge innovation for the SDGs in their respective countries. The CoP is open to government officials, practitioners, union leaders, civil society organizations, academics, and private sector representatives working with the public sector.



### E-learning Course on Changing Mindsets for Innovation and Digital Transformation in Caribbean SIDS

This e-learning course developed by ECLAC is designed for mid-level and senior public administrators in Caribbean Small Island Developing States (SIDS) who aim to drive innovation and digital transformation in public service delivery. Participants will learn to identify and overcome limiting mindsets, apply design thinking principles to reimagine services, and develop strategic approaches tailored to regional challenges. The course emphasizes collaborative frameworks to engage diverse stakeholders, change management strategies for fostering new mindsets, and evaluation techniques aligned with the SDGs.



### Policy Brief on Governance Futures in the Caribbean Small Island Developing States: Key Insights and Policy Implications

This Policy Brief, to be published by DPIDG/UN DESA, explores possible governance futures in the Caribbean, drawing on insights from a regional workshop held in Barbados in May 2025 attended by 16 SIDS. Through the lens of strategic foresight, it identifies and analyzes key drivers of change—political, economic, social, technological, and environmental—and considers how these forces may reshape governance by 2040. The Brief presents a range of transformational scenarios, their interconnections, and a shared vision for resilient, inclusive, and future-ready governance in Caribbean SIDS.
