**Distinguished delegates,**

**As the SDG 16 Conference 2025 concludes, I extend my sincere gratitude for your insightful contributions to our rich discussions.**

**Our deliberations have powerfully underscored the necessity of collective actions in addressing the interlinked challenges of peace, justice, and strong institutions. The diverse perspectives and experiences shared have deepened our understanding, and reminded us of the scale—and the profound urgency—of the task before us.**

**A resounding message from today’s Conference is clear: investing in peace, justice and effective institutions yields transformative, long-term dividends, driving inclusive economic growth, strengthening resilience, and fostering social cohesion. Non-discriminatory and gender-responsive policies must create meaningful pathways for marginalized and underrepresented groups to engage in public life.**

**Crucially, we cannot overlook strengthening the rule of law at all levels. It underpins rights, fosters peace and accountability of public institutions, and creates the enabling conditions for inclusive economies and sustainable development.**
