- Established by ECOSOC through its resolution 2001/45
- 24 Expert Members are nominated by the UN Secretary-General
- First CEPA Session in 2002
- CEPA provides policy advice and programmatic guidance to the ECOSOC on issues related to public administration and development
- CEPA aims to contribute to the advancement of internationally agreed development goals including the Millennium Development Goals (MDGs)
