## Overview

- 9.1 The Department of Economic and Social Affairs is responsible for the implementation of the work programme under this section. The programme is guided by the General Assembly, the Economic and Social Council and relevant functional commissions and standing committees. Accordingly, the programme of work contained in subprogrammes is guided by the various intergovernmental bodies and subsidiary organs as follows: Second and Third Committees of the General Assembly; Statistical Commission; Commission for Social Development; Commission on the Status of Women; Commission on Population and Development; Committee on Development Policy; Committee of Experts on Public Administration; Committee of Experts on International Cooperation in Tax Matters; Committee on the Elimination of Discrimination against Women; Commission on Sustainable Development; Committee on Non-Governmental Organizations; United Nations Forum on Forests; and Permanent Forum on Indigenous Issues.
- 9.2 The activities for which the Department is responsible fall within the framework of programme 7, Economic and social affairs, of the biennial programme plan and priorities for the period 2006-2007.
- 9.3 The biennial programme plan defines the overall orientation of the programme as supporting and advancing international cooperation in the pursuit of sustained economic growth, poverty eradication and sustainable development through an integrated approach encompassing economic, social, environmental, gender and population dimensions.
- 9.4 The programme is guided by the comprehensive policy framework for poverty eradication and development provided by the United Nations conferences of the 1990s, the Millennium Summit, the International Conference on Financing for Development and the World Summit on Sustainable Development and seeks to promote integration and coordination in the implementation of their outcomes and their follow-up. The International Meeting to Review the Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, the ten-year review and appraisal of the Beijing Platform for Action, the ten-year review of the World Summit for Social Development and the High-level Plenary Meeting of the sixtieth session of the General Assembly to review the progress made in implementing the Millennium Declaration in 2005 will have important programmatic implications for the Department. While focused on global policy development, the programme's activities are geared to promoting mutual reinforcement between global policies and regional and national policies and actions.
- 9.5 Thus oriented, the programme undertakes four main activities:
  - (a) Firstly, it compiles a wide range of economic, social and environmental data and information and analyses them with a view to identifying trends and taking stock of policy options;
  - (b) Secondly, it reviews development issues and policies in order to deepen the international community's understanding of global challenges in the economic and social spheres and to assist Member States in reaching consensus on the most appropriate responses to these challenges;
  - (c) Thirdly, it advises Member States on the ways and means to translate globally agreed policies into country-level action and, through technical cooperation, helps build national capacities;
  - (d) Fourthly, it provides a central capacity within the Secretariat to promote policy and programme coherence among the economic and social sectors of the Organization and to orient and organize cooperation and coordination in the economic and social area between the United Nations and the specialized agencies, as well as within the United Nations system as a whole, particularly in support of the central intergovernmental bodies.

- 9.6 The Department carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system as well as external entities, including: the Bretton Woods institutions; regional and national organizations; non-governmental organizations; and academic communities. Such collaboration and cooperation include the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.
- 9.7 In the context of its responsibilities for assisting the Secretary-General in enhancing policy coherence in the management of the economic and social activities of the United Nations, the Department will seek to enhance the support it provides to the Under-Secretary-General for Economic and Social Affairs in his role as convenor of the Executive Committee on Economic and Social Affairs and as Programme Manager of the United Nations Development Account. Management practices in the Department of Economic and Social Affairs, at both the departmental and divisional levels, are geared to continuous streamlining and updating of the programmes, making it possible for most of the new legislative requests to be absorbed either through better use of resources or productivity gains. In a number of areas, however, further absorption is not proving feasible, because of the nature and scale of new requirements and the substantial, new responsibilities assigned to the Department. Thus, in the areas of financing for development and indigenous issues and with regard to additional tasks in support of the intergovernmental process on disability the proposed budget includes a modest increase.
- 9.8 The expected accomplishments and indicators of achievement for the Department in the biennium 2006-2007 are detailed, together with resources, under executive direction and management and the programme of work. The overall framework of these expected accomplishments and indicators of achievement is shown in table 9.1 below.

- 9.9 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in the summary in table 9.2 below and as distributed in the output information for each subprogramme.

9.10 The overall resources required for the biennium 2006-2007 for this section amount to \$145,140,000 before recosting, reflecting an increase of \$2,112,300 (or 1.5 per cent). The growth shown in table 9.4 below can be summarized as follows:

- (a) The net increase of \$56,800 under policymaking organs relates to \$283,800 for travel of members of the Committee of Experts on Public Administration and the Committee of Experts on International Cooperation in Tax Matters in order to reflect recent legislative mandates changing the frequency of sessions from biennial to annual sessions, offset by reduced requirements for non-posts resources relating to one-time provisions in 2004-2005 for the follow-up to the Fourth World Conference on Women (\$227,000);
- (b) The net increase of \$437,100 under executive direction and management relates to \$396,600 for posts, arising from full funding of 1 ASG and 1 P-5 post established in 2004-2005, and \$40,500 for the redeployment of non-post resources from subsection D, Programme support;
- (c) The net increase of \$2,515,400 under programme of work relates to:
  - (i) An increase of \$177,700 under subprogramme 1, comprising \$167,500 for full funding of 1 P-5 post established in 2004-2005, and \$10,200 for redeployment of non-post resources from subsection D, Programme support;
  - (ii) An increase of \$101,400 under subprogramme 2, arising from the redeployment of non-post resources from subsection D, Programme support, and in response to General Assembly resolution 59/168;
  - (iii) An increase of \$686,600 under subprogramme 3 comprising \$474,900 for full funding of 1 P-3 and 1 P-2 post established in 2004-2005, two new P-3 posts to support the work of the Ad Hoc Committee on Disability and the Permanent Forum on Indigenous Issues, and \$211,700 for the redeployment of non-post resources from subsection D, Programme support, and in response to General Assembly resolutions 59/198 and 59/174;
  - (iv) An increase of \$457,100 under subprogramme 4 comprising \$350,000 for full funding of 1 P-5 and 1 P-3 post established in 2004-2005 and \$107,100 for redeployment of non-post resources from subsection D, Programme support, and in response to General Assembly resolution 59/229;
  - (v) An increase of \$195,000 under subprogramme 5 for non-post resources arising essentially from redeployment of non-post resources from subsection D, Programme support;
  - (vi) An increase of \$415,700 under subprogramme 6, comprising \$285,600 for full funding of 1 P-5 and 1 P-3 post established in 2004-2005 and \$130,100 for non-post resources arising from redeployment of resources from subsection D, Programme support, and in response to General Assembly resolution 59/124;

- (vii) A net increase of \$73,400 under subprogramme 7, comprising a decrease of \$49,600 arising from outward redeployment of 1 P-3 post in exchange for 1 P-2 post from subprogramme 10 offset by an increase of \$123,000 for the redeployment of non-post resources from subsection D, Programme support, and in response to Economic and Social Council resolution 1998/46;
  - (viii) A net decrease of \$385,900 under subprogramme 8, comprising a decrease of \$512,400 arising from outward redeployment of 2 General Service (Other level) posts, abolition of 2 General Service (Other level) posts, offset by an increase of \$126,500 for the redeployment of non-post resources from programme support and in response to General Assembly resolution 58/231;
  - (ix) An increase of \$2,000 under subprogramme 9 for non-posts arising essentially from redeployment of non-post resources from subsection D, Programme support;
  - (x) An increase of \$792,400 under subprogramme 10, comprising \$792,900 for full funding of 1 P-5, 1 P-4 and 1 P-3 post established in 2004-2005, 1 new P-5 post proposed for 2006-2007, inward redeployment of 1 P-3 from subprogramme 7 in exchange for 1 P-2, inward redeployment of 1 General Service (Other level) from subprogramme 8, and a decrease of \$500 for non-post resources arising from a reduction of contractual services (\$34,500) and the redeployment of resources (\$34,000) from subsection D, Programme support, in response to General Assembly resolution 59/225;
- (d) A net increase of \$203,400 under programme support relates to an increase of \$128,100 for inward redeployment of one General Service (Other level) post and a net increase of \$75,300 for non-post resources to cover the Department's share of centrally provided data-processing and communications infrastructure services costs (\$978,000), offset by reduced requirements due to redeployment of provisions to executive direction and management and the various subprogrammes to account for such requirements under the respective areas (\$902,700);
- (e) The decrease of \$1,092,400 under subsection E, advance to the United Nations International Research and Training Institute for the Advancement of Women (INSTRAW), relates to the one-time provision for 2005, in support of current efforts to revitalize INSTRAW and ensure that the Institute functions at least for 2005.
- 9.11 In the context of the preparation of the present programme budget proposals, the Executive Committee on Economic and Social Affairs, convened by the Under-Secretary-General for Economic and Social Affairs, undertook a collaborative programmatic review of the 11 clusters that encompass the totality of the economic and social programme activities covered in the programme budget. The review was intended to ensure that United Nations economic and social entities have a common assessment of the expectations and priorities of Member States and how to meet them and of ways to maximize synergies within the Organization. An immediate concern was to align the activities and initiatives covered in the present proposed programme budget so that together they would have maximum impact on advancing the priorities of the Millennium Declaration and the global conferences and summits. By generating greater awareness of programme objectives and proposed activities, and thus furthering opportunities for closer collaboration, particularly between global and regional entities, the current programme budget should lead to more systematic collaboration and greater overall effectiveness.
- 9.12 The overall purpose of the Department's technical cooperation activities is to support the efforts of the developing countries and countries with economies in transition, strengthen national capacities and promote the sharing of development expertise and best practices. In line with the orientations that guided the reforms of the Secretary-General, the Department approaches its technical cooperation functions not as a stand-alone activity, but as an integral component of its overall work

programme, closely linked to the normative and analytical functions it carries out in the specific economic and social areas covered by its programme of work. Across these areas, the mission of the Department's technical cooperation programme is to facilitate and support national efforts to meet in an integrated way the commitments, targets and goals of international conferences, including the Millennium Summit, the International Conference on Financing for Development, the World Summit on Sustainable Development, the World Summit on Social Development and the Fourth World Conference on Women. Based on its experience in carrying out its technical cooperation programme, the Department provides feedback to the intergovernmental processes on the progress and barriers faced in achieving these goals, thereby helping to link international policy deliberations and national policy implementation.

- 9.13 During the biennium 2006-2007, the projected extrabudgetary resources amounting to \$114,056,700 will supplement resources from the regular budget to finance various activities, such as technical advisory services, training, workshops, seminars and field projects.
- 9.14 The Department views evaluation as an integral part of the programme cycle. In this regard, the resources allocated to the programme implementation will be used to some extent to evaluate the Department's major outputs and activities. It is estimated that \$1,500,000 will be dedicated to such activities, consisting of \$1,050,000 under the regular budget and \$450,000 of extrabudgetary resources. The exact scale of evaluation activities in the biennium 2006-2007 will be determined during the course of the biennium based on the implementation of evaluation plans developed for all substantive subprogrammes. The Department will also be collaborating with the Office of Internal Oversight Services on a number of triennial reviews, due for the biennium 2006-2007, and on ad hoc evaluations. It is foreseen that resources will be directed to training of staff in improving skills in monitoring and evaluation. The Department has used the concept of logical frameworks for elaborating time-bound results for the period 2006-2007 in order to strengthen monitoring of the programme. The Department will continue to develop monitoring and evaluation tools to improve oversight and management of its technical cooperation activities and projects funded under the Development Account. Results-based logical frameworks will consistently be applied to technical cooperation activities such as workshops and projects.
- 9.15 The estimated percentage distribution of the total resources to be made available to the Department in the biennium 2006-2007 will be as follows:

- 9.16 Provision is made for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the substantive servicing of which is the responsibility of the Department and which are deemed to require specific provisions.
- 9.17 The amount of \$3,595,400 includes a net increase of \$56,800 for travel of members of the Committee of Experts on Public Administration and the Committee of Experts on International Cooperation in Tax Matters in order to reflect recent legislative mandates changing the frequency of sessions from biennial to annual sessions (\$283,800) offset by reduced requirements of \$227,000 for non-post resources relating to one-time provisions in 2004-2005 for the follow-up to the Fourth World Conference on Women.

## **1. Standing intergovernmental organs and expert bodies**

### **Statistical Commission**

#### ***Resource requirements (before recosting): \$95,100, at the maintenance level***

- 9.18 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I) of 16 and 18 February 1946. Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) of 21 June 1946 and 1566 (L) of 3 May 1971, are to assist the Council in promoting the development of national statistics and the improvement of their comparability; coordinating the statistical work of the specialized agencies; developing the central statistical services of the Secretariat; advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and promoting the improvement of statistical methods in general.
- 9.19 Bearing in mind General Assembly resolution 50/227 of 24 May 1996 on the restructuring and revitalization of the United Nations in the economic, social and related fields and the need to provide for more continuity in the Commission's decision-making and oversight of the global statistical process, and with the aim of enabling the Commission to follow-up on the statistical implications of the major United Nations conferences and summits, as well as the agreed conclusions of the high-level coordination segments of the annual sessions of the Economic and Social Council, the Council, in its resolution 1999/8, decided that the Statistical Commission should meet annually for a period of four working days in New York, beginning in 2000. The Council also decided that the Working Group on International Statistical Programmes and Coordination, established in its resolution 1306 (XLIV) of 31 May 1968, should cease to function.
- 9.20 The thirty-eighth and thirty-ninth sessions of the Statistical Commission are scheduled to be held in 2006 and 2007, respectively.

### **Commission on Population and Development**

#### ***Resource requirements (before recosting): \$109,200, at the maintenance level***

- 9.21 The Population Commission was established by the Economic and Social Council in its resolution 3 (III) of 3 October 1946. Its terms of reference were initially set out in Council resolution 150 (VII) of 10 August 1948. Following the International Conference on Population and Development and its adoption of its Programme of Action, the General Assembly, in its resolution 49/128 of 19 December 1994, renamed the Population Commission the Commission on Population and Development, decided that it should meet on an annual basis and revised its terms of reference. The mandate of the Commission was further revised by the Assembly in its resolution

50/124 of 20 December 1995. The membership of the Commission was increased from 27 to 47, with each member elected for a four-year term (Council decision 1995/320). The Commission normally meets annually for a period of five working days.

- 9.22 The revised mandate of the Commission includes arranging for studies and advising the Economic and Social Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and international levels, identifying reasons for success and failure and advising the Council thereon; and reviewing the findings of research and analysis pertaining to the interrelationship between population and development at the national, regional and international levels and advising the Council thereon.

### **Commission for Social Development**

*Resource requirements (before recosting): \$182,200, at maintenance level*

- 9.23 The Social Commission was established as a functional commission of the Economic and Social Council by Council resolution 10 (II) of 21 June 1946. As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI) of 29 July 1966, renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. The Council also decided that the Commission should review its mandate, terms of reference and scope of work in order to develop its multi-year programme of work and should review the frequency of its meetings in the light of its responsibility for the follow-up to and review of the implementation of the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 and that it should meet in annual sessions of eight working days. The Council also decided to invite experts to participate in the meetings of the Commission when priority subjects addressed in the Copenhagen Declaration and Programme of Action were under discussion. The forty-fourth and forty-fifth sessions of the Commission for Social Development are scheduled for the first quarters of 2006 and 2007, respectively.

### **Commission on the Status of Women**

*Resource requirements (before recosting): \$212,600, at the maintenance level*

- 9.24 The Commission on the Status of Women was established as a functional commission of the Economic and Social Council by Council resolution 11 (II) of 21 June 1946. Originally 15, the membership was increased to 18 in 1951, to 21 in 1961 and to 32 in 1966. By its resolution 1989/45, the Council decided to enlarge the membership to 45 in 1990. The Commission reports to the Council on matters concerning the promotion of women's rights in the political, economic, social and educational fields and makes recommendations to the Council on problems requiring immediate attention in the field of women's rights. It meets annually in New York for 10 working days. Its sessions bring together observers from both within and outside the United Nations system.

- 9.25 The Commission has a central role within the United Nations system in monitoring the implementation of the Beijing Declaration and Platform for Action and in advising the Council thereon in accordance with its strengthened mandate. In its resolution 1996/6, the Council gave the Commission a catalytic role in mainstreaming gender perspectives in policies and programmes and confirmed its existing mandates. In accordance with General Assembly resolution 52/100 of 12 December 1997, the Commission served as the open-ended preparatory Committee for the review and appraisal of the Platform for Action. Its forty-fourth session, in 2000, was extended by five days. The twenty-third special session of the General Assembly, entitled “Women 2000: gender equality, development and peace for the twenty-first century”, was held from 5 to 9 June 2000.
- 9.26 In line with Economic and Social Council resolution 1995/29, the Commission established an open-ended working group responsible for drafting an optional protocol to the Convention on the Elimination of All Forms of Discrimination against Women, which meets in parallel to the Commission. The Optional Protocol to the Convention was adopted by the General Assembly in its resolution 54/4 of 6 October 1999 and entered into force on 22 December 2000.

### **Commission on Sustainable Development**

#### ***Resource requirements (before recosting): \$474,500, at the maintenance level***

- 9.27 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by Council decision 1993/207 of 12 February 1993. Its functions are set out in General Assembly resolution 47/191 of 22 December 1992. The Commission is composed of 53 members elected for terms of office of three years, meets annually for a period of two to three weeks and receives substantive and technical services from the Department. The Commission reports to the Economic and Social Council and provides recommendations to the General Assembly through the Council. As a result of the World Summit on Sustainable Development and Economic and Social Council resolution 2003/61 on the future programme of work of the Commission on Sustainable Development, the work of the Commission is now organized in a series of two-year action-oriented implementation cycles, which include a review session and a policy session. It will continue to meet annually as in the past; every second year will be reserved for intergovernmental negotiations. The review session will focus on the results of implementation by Governments, international organizations and major groups at the national and regional levels and will establish the topics to be negotiated in the following year’s session of the Commission. The overall workload of the Commission will remain unchanged.

### **Committee for Development Policy**

#### ***Resource requirements (before recosting): \$318,600, at the maintenance level***

- 9.28 The Economic and Social Council, in annex I to its resolution 1998/46 of 31 July 1998, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) of 15 August 1964 and 1079 (XXXIX) of 28 July 1965 and decision 1995/215 of 10 February 1995, the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts with expertise drawn from the fields of economic development, social development and environmental protection and who reflect adequate geographical and gender balance. Its membership includes experts who are able to make a contribution on emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.

- 9.29 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. The Council decides on the work programme of the Committee. The Committee meets in annual session for five working days and submits its report to the Council at its substantive session in July. The report includes the Committee's proposals to the Council concerning its programme of work for the following year for consideration and approval. The General Assembly, the Secretary-General and the subsidiary bodies of the Economic and Social Council may propose, through the Council, issues for consideration by the Committee. Information on the Committee's work is disseminated, inter alia, through an Internet website and through a presentation by its Bureau following the outcome of its deliberations. In undertaking its responsibilities, the Committee, in addition to holding formal meetings, also explores the scope for effective preparations of its deliberations through informal networking arrangements, with the assistance of the Secretariat. With respect to the submission of its report to the Council, the Committee has decided that its Chairman or a designated member should attend the session of the Council to introduce the report and respond to any queries raised.

### **Committee on the Elimination of Discrimination against Women**

#### ***Resource requirements (before recosting): \$1,142,200, at the maintenance level***

- 9.30 The Committee on the Elimination of Discrimination against Women was established in accordance with the Convention on the Elimination of All Forms of Discrimination against Women, adopted by the General Assembly in its resolution 34/180 of 18 December 1979. It reviews reports of States parties submitted in accordance with article 18 of the Convention and formulates suggestions and general recommendations. The Committee reports annually through the Economic and Social Council to the Assembly. Beginning from 1997, the 23-member Committee holds two regular annual sessions in New York of 15 working days each, and a five-day pre-session working group.
- 9.31 The Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women was adopted by the General Assembly in its resolution 54/4 of 6 October 1999 and entered into force on 22 December 2000. The Committee is mandated under the Optional Protocol to the Convention to receive and consider communications from individuals or groups of individuals and to transmit its views with respect to such communications to the parties concerned. It is also empowered under the Optional Protocol to conduct inquiries into grave or systematic violations of the Convention in States parties.
- 9.32 During 2006-2007, it is expected that the Committee will be required to consider up to 20 communications from an estimated total of at least 500. This will require the Committee to determine whether each communication is admissible and whether the communication establishes a violation of the Convention (that is, whether it is a violation on the merits). In order to meet the additional responsibilities related to the Optional Protocol, a Working Group of the Committee meets prior to each session in order to determine the admissibility of communications and make the necessary recommendations on the merits. The Working Group comprises five members of the Committee, who meet for a period of five working days prior to each session for a total of 10 working days annually. The Working Group submits its report to the Committee at its next session. The same level of conference servicing provided to the Committee is required for the five-day session of the Working Group, including interpretation (6 languages) and translation of pre-session documentation and in-session documentation.

**Committee of Experts on Public Administration**

*Resource requirements (before recosting): \$298,400, reflecting an increase of \$126,900*

- 9.33 The Committee of Experts on Public Administration, which since 2003, holds annual sessions (as per Economic and Social Council resolution 2003/60), was established by the Economic and Social Council in its resolution 2001/45 and consists of 24 experts appointed in their personal capacity by the Council upon the nomination of the Secretary-General. It held its first session at the United Nations Headquarters from 22 to 26 July 2002. The Committee is the successor of the former Group of Experts on the United Nations Programme in Public Administration and Finance, which met biennially. The Committee's role is to support Member States in building capacity to meet the basic needs of their populations through the discussion of themes relating to the role of the public sector in the development process.

**Committee of Experts on International Cooperation in Tax Matters**

*Resource requirements (before recosting): \$315,500, reflecting an increase of \$156,900*

- 9.34 By its resolution 2004/69 of 11 November 2004, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee is comprised of 25 members nominated by Governments and acting in their expert capacity. The members, who are appointed by the Secretary-General, after notification of the Council, for a term of four years, are drawn from the fields of tax policy and tax administration and their appointment reflects an adequate equitable geographical distribution, representing different tax systems. As of 2005, the Committee meets on a yearly basis for a period of five days in Geneva.
- 9.35 The Committee of Experts on International Cooperation in Tax Matters is mandated to: keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; make recommendations on capacity-building and the provision of technical assistance to developing countries and countries with economies in transition; and give special attention to developing countries and countries with economies in transition in dealing with all the above issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.

**United Nations Forum on Forests**

*Resource requirements (before recosting): \$131,600, at the maintenance level*

- 9.36 By its resolution 2000/35 of 18 October 2000, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Economic and Social Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights. As a functional commission of the Council, the Forum meets annually, for a period of up to two weeks. The Forum also holds a high-level ministerial segment of two to three days duration, as required. The high-level segment includes a one-day policy

dialogue with the heads of organizations participating in the Collaborative Partnership on Forests, which ensures the opportunity to receive and consider inputs from representatives of major groups, in particular, through the organization of multi-stakeholder dialogues.

- 9.37 The Forum works on the basis of a multi-year programme of work and is mandated to perform a set of principal functions related to: implementation; policy development; international coordination among organizations, instruments and institutions; international cooperation; monitoring, assessment and reporting; and strengthening political commitment. In addition, the Forum: developed and adopted a plan of action at its second session; addresses emerging areas of priority concern at each session; gives guidance to and services the Collaborative Partnership on Forests; has begun to devise approaches towards appropriate financial and technology support; and will consider, with a view to recommending, the parameters of a mandate for developing a legal framework on all types of forests. The effectiveness of the Forum is expected to be reviewed in 2005, at which time the institutional framework of the Forum, including its position within the United Nation system, will be addressed.

### **Permanent Forum on Indigenous Issues**

#### ***Resource requirements (before recosting): \$315,500, at the maintenance level***

- 9.38 The Economic and Social Council, in its resolution 2000/22, decided to establish, as a subsidiary organ of the Council, a permanent forum on indigenous issues, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council, and 8 members to be appointed by the President of the Council following formal consultations with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency, representative and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.
- 9.39 The Economic and Social Council decided that the Permanent Forum shall hold an annual session of 10 working days at the United Nations Office at Geneva or at United Nations Headquarters or at such other place as the Permanent Forum may decide in accordance with existing financial rules and regulations of the United Nations.

## **2. Special sessions and intergovernmental processes launched by the General Assembly**

### **Follow-up to the Fourth World Conference on Women**

#### ***Resource requirements (before recosting): decrease of \$227,000***

- 9.40 The decrease is due to one-time provisions of \$227,000 for consultants and expert group meetings during the biennium 2004-2005 for the review of the implementation of the Beijing Platform for Action and the outcome documents of the twenty-third special session of the General Assembly.

## B. Executive direction and management

*Resource requirements (before recosting): \$5,481,900*

- 9.41 The Under-Secretary-General for Economics and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and approved programme of work. The Under-Secretary-General also serves as convenor of the Executive Committee on Economic and Social Affairs, whose membership comprises the Department of Economic and Social Affairs, the regional commissions, the United Nations Conference on Trade and Development (UNCTAD), the United Nations Environment Programme (UNEP), the United Nations Centre for Human Settlements, UN-Habitat, the United Nations Office on Drugs and Crime, the Office of the United Nations High Commissioner for Human Rights and the United Nations Development Programme (UNDP) and also includes the United Nations University and the research/training institutes INSTRAW, the United Nations Research Institute for Social Development (UNRISD) and the United Nations Institute for Training and Research (UNITAR). The Executive Committee on Economic and Social Affairs is one of the four Executive Committees established as an important component of the reform process launched by the Secretary-General in early 1997. Its aim is to sharpen the contribution that each unit makes to the overall objectives of the Organization by reducing duplication of effort and facilitating greater complementarity and coherence. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs, the Assistant Secretary-General for Economic Development and the Assistant Secretary-General and Special Adviser to the Secretary-General on Gender Issues and Advancement of Women. The Assistant Secretaries-General support the Under-Secretary-General in ensuring the effective integration of the capacities of the different organizational units of the Department for normative, analytical and technical cooperation work, with a view to maximizing complementarity and synergy within the Department as a whole.
- 9.42 In particular, the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs assists the Under-Secretary-General in respect of executive direction and management and the coordination of the Department's technical cooperation activities, as well as by overseeing substantive support to the Economic and Social Council and other relevant intergovernmental bodies. As part of the effort to enhance mutual reinforcement between intergovernmental and inter-agency coordination work, he also serves as Secretary of the United Nations System Chief Executives Board for Coordination (CEB), reporting, in that capacity, to the Secretary-General.
- 9.43 The Assistant Secretary-General for Economic Development assists the Under-Secretary-General by providing senior substantive policy guidance within the Department in the areas of macroeconomic analysis, financing for development, economic and social monitoring, data gathering and dissemination and knowledge management.
- 9.44 The functions of the Special Adviser on Gender Issues and Advancement of Women and the staffing requirements of her office are reflected under subprogramme 2, Gender issues and advancement of women.
- 9.45 The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development on the planning, coordination, management and assessment of the work programme of work of the Department. The Office also assists the Under-Secretary-General in his or her capacity as the programme manager of the Development Account.

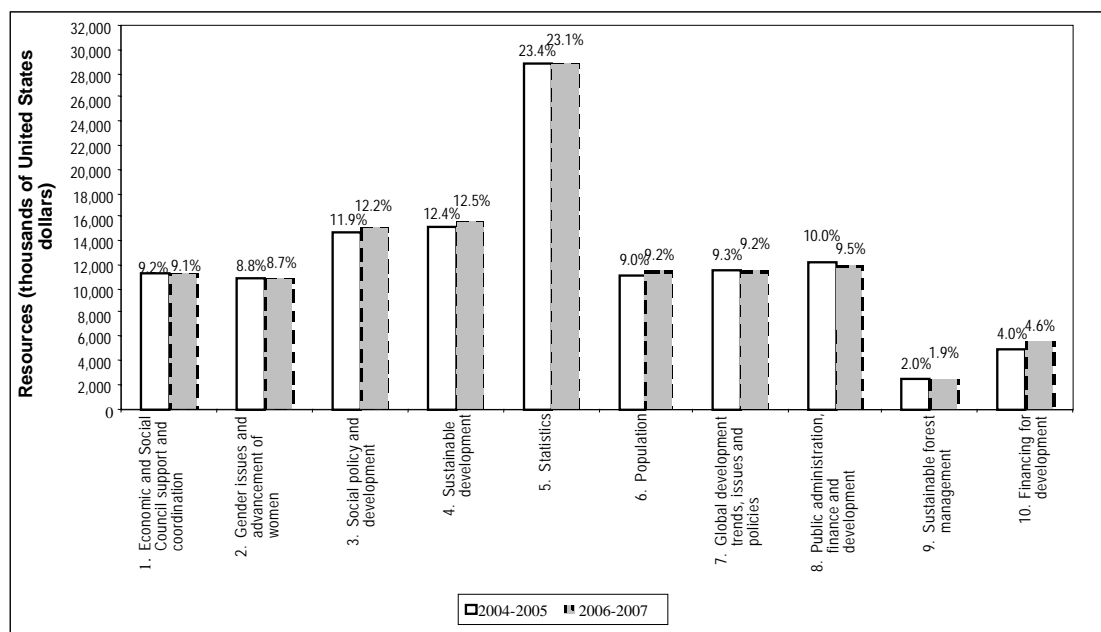
- 9.46 The amount of \$4,139,000 for posts, reflecting an increase of \$396,600, provides for full funding of one ASG post and one P-5 post established in 2004-2005. The amount of \$1,342,900 for non-post requirements, reflecting an increase of \$40,500, provides for: general temporary assistance (\$190,500); overtime (\$22,500); consultants and experts (\$182,900); travel of staff (\$530,000); supplies and materials (\$6,000); furniture and equipment (\$12,000) and the United Nations contribution to the activities of the Non-Governmental Liaison Service (\$399,000). The increase reflects redeployment of resources for overtime, supplies and materials and office automation equipment heretofore reflected under subsection D, Programme support, to better account for requirements of the Office.

- 9.48 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) policymakers and other relevant actors at the national and international level will contribute to the work of the General Assembly and the Economic and Social Council to promote a more coherent and integrated approach to the implementation of internationally agreed socio-economic goals and targets; (b) there is a national and international environment conducive to the achievement of economic growth, sustainable development and poverty eradication, as outlined in the socio-economic goals and targets contained in the Millennium Declaration and major United Nations conferences; (c) relevant actors are well informed about the work of the General Assembly and the Economic and Social Council and provide well-coordinated and timely inputs; (d) the international community is responsive to the policy guidance provided by the General Assembly and the Economic and Social Council in the socio-economic areas, including in the context of conflict prevention and post-conflict situations.

- 9.50 The amount of \$10,904,200 for posts includes an increase of \$167,500 resulting from the full funding of one new P-5 post for a Senior non-governmental organization Officer, established in the biennium 2004-2005.

## **Subprogramme 2**

### **Gender issues and advancement of women**

*Resource requirements (before recosting): \$10,877,200*

- 9.52 Subprogramme 2, Gender issues and advancement of women, will be implemented by the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women. The programme of work will strive to promote the effective implementation of the Beijing Declaration and Platform for Action of the Fourth World Conference on Women, the outcome of their review by the General Assembly at its special session held in June 2000, the relevant resolutions of the principal organs of the United Nations, including the Security Council, the General Assembly and the Economic and Social Council, and gender-related commitments contained in the Millennium Declaration. The subprogramme works towards ensuring women's full enjoyment of their human rights and supports the mainstreaming of gender perspectives in the work of the United Nations. The improvement of the gender balance and of gender equality in the United Nations Secretariat and promotion of a more gender-sensitive work environment are also part of the subprogramme's objectives.
- 9.53 The Special Adviser reports directly to the Secretary-General on: gender issues, including the progress made by departments and offices in the United Nations Secretariat and the secretariats of the organizations and bodies of the United Nations system in mainstreaming a gender perspective in every sector; the status of women in the Secretariat; progress made to achieve the goal of having 50 per cent of Professional posts filled by women and related policies, strategies and activities; and actions aimed at creating a more gender-sensitive working environment. The Special Adviser, assisted by the Focal Point for Women in the Secretariat, supports and advises programme managers in their efforts to meet General Assembly-mandated targets on gender balance. Both the Special Adviser and the Focal Point participate in the development of a gender-sensitive and equitable working environment as described in the strategic plan of action for the improvement of the status of women in the Secretariat (1995-2000), which was endorsed by the General Assembly in its resolution 49/167 of 23 December 1994. The Assembly, in its resolution 58/148 of 22 December 2003, reaffirmed that the United Nations system should promote an active and visible policy of mainstreaming a gender perspective. As Chairperson of the Inter-Agency Network on Women and Gender Equality, the Special Adviser provides leadership in the area of gender mainstreaming in both the substantive and operational areas.
- 9.54 The Special Adviser provides leadership and oversees the work of the Division for the Advancement of Women, through its Director, and in this capacity reports to the Under-Secretary-General of the Department of Economic and Social Affairs. The Division prepares reports and parliamentary and other documentation and provides substantive services to the Commission on the Status of Women as well as the Economic and Social Council and General Assembly on items relating to gender equality and women's human rights. It also provides substantive and technical servicing to the Committee on the Elimination of Discrimination against Women and the Inter-Agency Network on Women and Gender Equality. The Division provides advisory services and technical assistance to developing countries and countries with economies in transition, at their request, on implementing the Beijing Declaration and Platform for Action and the outcome of their review by the General Assembly at its special session in June 2000 and subsequent

intergovernmental mandates, as well as reporting on and implementing the Convention on the Elimination of All Forms of Discrimination against Women. It facilitates linkages and partnerships with non-governmental organizations, including through information dissemination and exchange.

- 9.57 The amount of \$10,133,100 provides for posts, at the maintenance level. The amount of \$744,100 for non-post requirements includes an increase of \$101,400 relating to other staff costs (\$42,800), reflecting an increase of \$11,400 for overtime; an increase of \$28,000 for consultants and experts (\$445,900); provision for travel of staff (\$154,700); provision for contractual services (\$34,900); provision for hospitality (\$3,800); an increase for supplies and materials (\$18,000); and an increase for office automation equipment (\$44,000). The implications of the outcomes of the International Meeting, if any, will be submitted to the General Assembly, at its sixtieth session, pursuant to the provisions of General Assembly resolution 58/269. ## Subprogramme 5 Statistics

*Resource requirements (before recosting): \$28,952,700*

- 9.69 The subprogramme falls within the responsibility of the Statistics Division. The programme of work has been formulated within the framework of subprogramme 5 of programme 7 of the biennial programme plan and priorities for the period 2006-2007. The structure of the Division's programme has four parts: statistical capacity-building; standards and methodological development; coordination of international statistical activities; and data dissemination. The strategic priority of the Statistics Division for the biennium 2006-2007 is the strengthening of international coordination on the production of socio-economic statistics at the country, regional and global level. This involves a comprehensive review of standards and quality of key socio-economic statistics at these three levels. Improving the statistical capacity in developing and countries in transition to produce accurate, timely and relevant socio-economic data remains the core of the programme. In particular, the Division will focus on strengthening country capacities to conduct the decennial censuses, as well as relevant social and economic surveys, to produce national accounts and to develop systems of environmental statistics.

9.72 The amount of \$26,662,400, at the maintenance level provides for posts. The amount of \$2,290,300 for non-post requirements, including a net increase of \$195,000, relates to other staff costs (\$284,900), including an increase of \$13,500 for overtime; a decrease of \$3,500 for consultants and experts (\$511,800); provision for travel of staff (\$145,300); provision for contractual services (\$451,500); an increase for supplies and materials (\$58,000); an increase for office automation equipment (\$127,000); and the Department's share of the payment to the International Computing Centre for the operation and maintenance of the mainframe and client server environment (\$711,800). - 9.73 The subprogramme falls within the responsibility of the Population Division. The programme of work has been formulated within the framework of subprogramme 6 of programme 7 of the biennial programme plan and priorities for the period 2006-2007.
- 9.74 The primary focus under the subprogramme will be enhancement of substantive support to and servicing of such intergovernmental bodies as the Commission on Population and Development, the Economic and Social Council and the General Assembly in relation to agenda items relevant to the field of population. Activities carried out under the subprogramme would be in support of the implementation of the recommendations contained in the Programme of Action adopted by the International Conference on Population and Development and key actions for the further implementation of the Programme of Action of the International Conference on Population and Development adopted at the special session of the General Assembly.

- 9.77 The amount of \$10,749,300 for posts reflects an increase of \$285,600 to provide for the full funding of two posts (1 P-5 and 1 P-3) established in 2004-2005 to strengthen the work on international migration. As a result of the fine-tuning of the restructuring of the Department, the two offices have been merged into a single division.

- 9.82 The amount of \$10,775,200 for posts includes a decrease of \$49,600. The decrease is the net effect of the outward redeployment of one P-3 post to subprogramme 10 for the Financing for Development Office in exchange for one P-2 post, resulting from the internal restructuring of the Department during the previous biennium as part of its effort to deploy necessary resources to areas of identified need. The amount of \$760,300 for non-post requirements, including an increase of \$123,000, relates to: provision for overtime (\$57,600, including an increase of \$8,700); consultants and experts (\$408,500, including an increase of \$26,200); travel of staff (\$132,200, including a decrease of \$700); contractual services (\$72,900, including a decrease \$300); an increase for supplies and materials (\$28,000); and an increase for office automation equipment (\$61,100). ## Subprogramme 8 Public administration, finance and development

### *Resource requirements (before recosting): \$11,958,900*

- 9.83 The subprogramme falls under the responsibility of the Division for Public Administration and Development Management. Guidance to the subprogramme is provided by the Committee of Experts in Public Administration. The programme of work has been formulated on the basis of subprogramme 8 of programme 7 of the biennial programme plan and priorities for the period 2006-2007. For over 50 years, the United Nations, through its programme in public administration, finance and development, has assisted Member States in their efforts to strengthen, improve and reform their governance systems and administrative institutions.
- 9.84 The Department focuses its knowledge, expertise and professionalism on critical substantive areas that are essential to the successful implementation of national programmes and policies. These include: governance systems and institutions, public service and management innovation, decentralization, integrity, transparency and accountability systems, social and economic governance, public finance and financial administration, knowledge systems and e-government and the role of the public sector in post-conflict reconstruction.

- 9.87 The amount of \$11,221,000 for posts includes a decrease of \$512,400. The decrease is the result of outward redeployment of 2 General Service (Other level) posts, one to subprogramme 10 and the other to programme support, and the abolition of 2 General Service (Other level) posts, resulting from fine-tuning the internal restructuring of the Department during the previous biennium as part of its efforts to deploy necessary resources to areas of identified need. The amount of \$737,900 for non-post requirements, including an increase of \$126,500, relates to: an increase for overtime (\$8,000); provision for consultants and experts (\$435,700, including an increase of \$45,000);

provision for travel of staff (\$165,200); provision for contractual services (\$55,500); an increase for supplies and materials (\$21,000); and an increase for office automation equipment (\$52,500). - 9.88 The subprogramme falls under the responsibility of the secretariat of the United Nations Forum on Forests. The programme of work has been formulated on the basis of subprogramme 9 of Programme 7 of the biennial programme plan and priorities for the period 2006-2007. The programme of work as presented is provisional.
- 9.89 Guidance to the subprogramme is provided by the United Nations Forum on Forests, which is to undertake the five-year review of the international arrangement on forests at its fifth session in April 2005. Following endorsement by the Economic and Social Council, at its substantive session in 2005, the implications of the review, if any, will be submitted separately to the General Assembly, at its sixtieth session, pursuant to the provisions of General Assembly resolution 58/269 of 23 December 2003.

- 9.95 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) policymakers at the national and international levels are fully engaged in the

- 9.97 The amount of \$5,405,700 for posts includes an increase of \$792,900. The increase results from full funding for three posts (1 P-5, 1 P-4 and 1 P-3) approved in the biennium 2004-2005; one new post at the P-5 level to provide additional capacity in the area of taxation in light of the Monterrey Consensus, which calls for the strengthening of international tax cooperation through dialogue and greater coordination work; inward redeployment of one P-3 post from subprogramme 7 in exchange for one P-2 post; and inward redeployment of one General Service (Other level) post from subprogramme 8 resulting from fine-tuning the internal restructuring of the Department during the previous biennium as part of its efforts to deploy necessary resources to areas of identified need.
- 9.98 The amount of \$362,800 for non-post requirements, including a net decrease of \$500, provides for overtime (\$42,000, including an increase of \$4,000); consultants and experts (\$170,100); provision for travel of staff (\$74,200); provision for contractual services (\$46,500, including a decrease of \$34,500); an increase for supplies and materials (\$7,000); and an increase for office automation equipment (\$23,000). An amount of \$34,000 of the increases relating to overtime, supplies and materials and office automation equipment relates to the redeployment of resources from subsection D, Programme support.

### 1. Executive Office

*Resource requirements (before recosting): \$7,769,100*

- 9.99 The Executive Office assists the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration. In addition, the Office provides administrative and programme support for the implementation of the operational programmes of the Department, including the Development Account, technical cooperation activities, extrabudgetary projects and other special operations.
- 9.100 In the biennium 2006-2007, the focus of the Office will be on enhancing the effectiveness of programme support, both in the traditional areas of responsibility and in streamlining the management and administration of the Department's extrabudgetary funds.

- 9.101 The amount of \$3,625,600, which provides for posts, reflects an increase of \$128,100, due to the inward redeployment of one General Service (Other level) post from subprogramme 8, to provide financial and administrative support for the implementation of the Development Account projects. The amount of \$4,143,500 for non-post requirements includes an increase of \$75,300, which is the net result of the following increases and decreases: (a) increases of: \$834,600 for contractual services to cover the Department's share of centrally provided data-processing infrastructure services costs, including those of storage area networks, application servers, departmental servers,

backup units and desktop connectivity; and \$143,400 for general operating expenses to cover the departmental share of centrally provided data-processing infrastructure support costs, including those of storage area networks, application servers, departmental servers, backup units and desktop connectivity and to provide for rental and maintenance of office automation, data-processing, television and other equipment, including the maintenance and support of the LAN technical infrastructure, the Integrated Management Information System, e-mail and other electronic services; and (b) decreases relating to redeployment of resources to executive direction and management and the various subprogrammes to account for such requirements under the respective areas: \$100,800 for general temporary assistance and overtime provisions; \$230,700 for supplies and materials; and \$571,200 for furniture and equipment.

## 2. Communications and Information Management Service

*Resource requirements (before recosting): \$2,828,700*

- 9.102 The Communications and Information Management Service, reporting to the Under-Secretary-General, is responsible for providing information technology and communications services to the Department, including the development and coordination of access to electronic information resources in the economic and social fields. The service has four main responsibilities, to formulate policies and strategies in the areas of knowledge management, electronic technical cooperation, website communications, publishing and electronic administration; to advance those policies and strategies through concrete information system projects; to acquire, manage and produce electronic information content; and to support operations in the form of network administration, computer helpdesk, database administration, information technology asset management and videoconferencing.
- 9.103 The service derives its mandate from the Secretary-General's track two reform agenda, specifically the instruction to create an electronic United Nations through expansion and innovation in the area of information technology and its application to the core functions of the Organization.
- 9.104 In addition, the service actively promotes electronic conferencing within the Department both to enhance knowledge networks on economic and social issues and to introduce savings in the implementation of expert consultations. Finally, the service produces an electronic newsletter on the work of the Department, DESA News, which is distributed to all staff in the Department and to other interested parties on the Web every two months. Information production and management account for approximately 20 per cent of total resources.

- 9.105 Post requirements are proposed at the maintenance level. Non-post requirements, reflecting a net decrease of \$8,000, would cover general temporary assistance during peak workload periods (\$11,800); an increase for overtime, redeployed from the Executive Office (\$2,000); contractual services (\$69,500, which reflects a decrease of \$24,000); supplies and materials (\$60,300); and furniture and equipment (\$14,000) at maintenance level.

### **E. Advance to the United Nations International Research and Training Institute for the Advancement of Women**

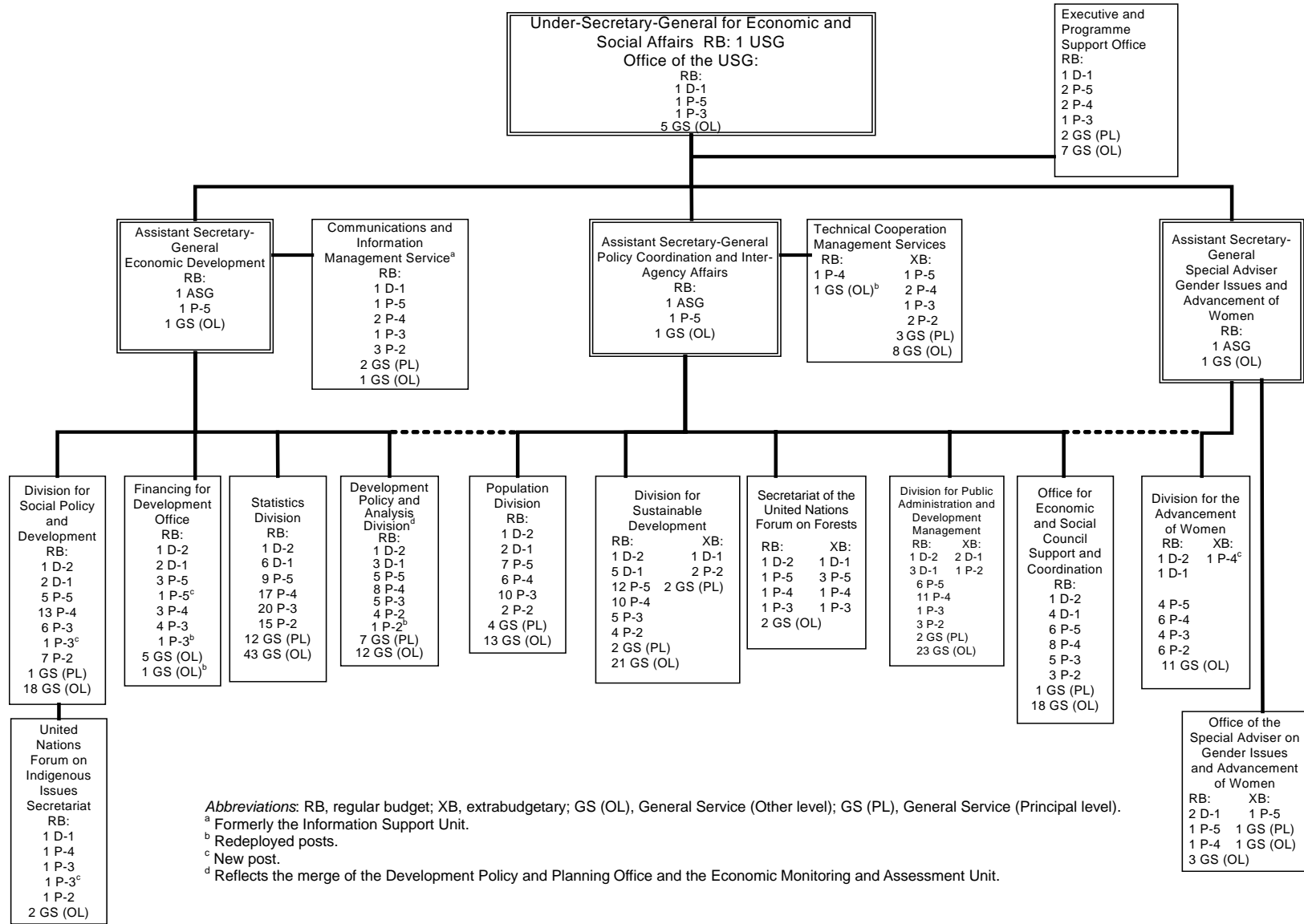
