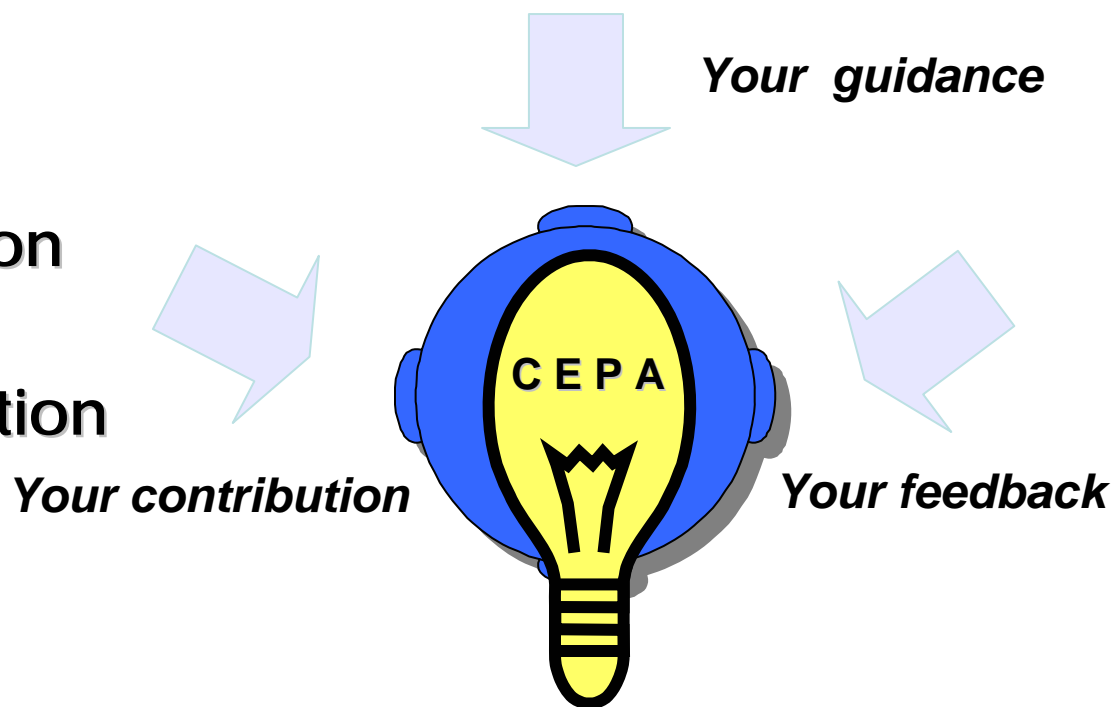

- ✓ Review of the UN Programme on Public Administration [This part includes (a) DPADM reports to CEPA on its past annual work; (b) CEPA members provide specific advices to its future strategic Framework.]

- How to better engage CEPA expertise in DPADM's work?

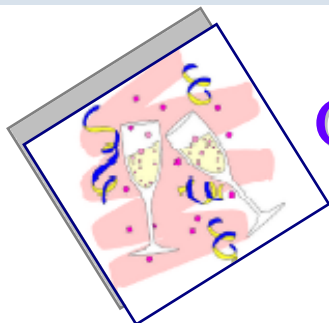


# CEPA: Direction

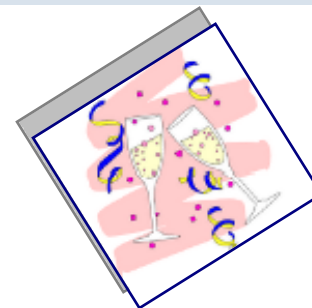
## 2009 CEPA Suggestions
