



The Survey includes digital government ranking of the 193 UN Member States.

The 2022 Survey also marks the first study to incorporate an assessment of e-government in the most populous city in each of UN Member State.




More than 20 years of data - and a vision of the future



Lao PDR's E-Government Development Index (EGDI) is ranked 159th globally in 2022, 8 spots up from 2020.

In e-participation, LAO PDR has progressed 43 places, ranked 132nd in the **E-Participation Index (EPI) in** 2022, compared to 175th in 2020.

The future of digital government

- **<u>Central role</u>** of digital government, digital economy, digital society and the SDGs
- Changing institutional dimension of e-government, from silos to <u>whole-of-government</u>, <u>whole-of-society</u>, and integrated strategies covering multiple sectors, multilevel (across local jurisdictions) and multistakeholder (with private sector, academia and civil society) dimensions
- Role of digital government in <u>responding to crisis and emergencies</u> such as pandemics and conflict, supporting a responsive and resilient government
- Role of <u>AI, analytics and frontier technologies</u> in driving anticipatory, predictive and responsive services
- Need for a national data framework/strategy in supporting to digital government strategy

Data Trends

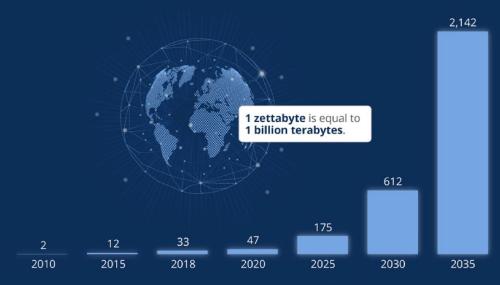
Digital data is "a reinterpretable representation of information in a formalized manner, suitable for communication, interpretation or processing", which is authored/generated by people or machines/sensors, or as a by-product.

Data grows rapidly, and will increase more than tenfold from 175 zettabytes in 2025 to 2,142 zettabytes in 2035 (Note: One zetta is a "1" followed by 21 zeroes)

Close to 50 per cent will be stored in the public cloud
