

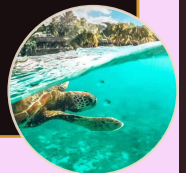




Digital Transformation
