Ms. Adriana Alberti is Chief, Programme Management and Capacity Development Unit, Division for Public Institutions and Digital Government (DPIDG), UN Department of Economic and Social Affairs (UN DESA). She has thirty years of international knowledge and expertise in governance and public administration. She coordinated and contributed to a number of UN publications, including the UN E-Government Survey. She has led capacity development activities in over 25 countries from around the world, including on innovation in governance and digital government. She coordinated the UN Public Service Forum and Awards programme. As Chief Technical Advisor, she managed an innovation programme in the Middle East, North Africa, and Western Balkans.

Prior to joining the UN, she worked at the University of Bologna and taught at several universities. She was Visiting Fellow at Princeton University, the Institute of Advanced Social Studies in Spain, and the University of Birmingham in the United Kingdom. She was awarded fellowships from the Italian National Research Council, the European University Institute, the Government of Spain for the Salvador de Madariaga Research Grant, and Harvard University.

She holds a Ph.D. in Social and Political Sciences from the European University Institute; a master's degree in Political Science magna cum laude from the University of Bologna and an Executive Education certificate from Harvard University.



Prof. Ludeki Chweya, Ph.D, CBS, is presently the Director General & Chief Executive Officer of the Kenya School of Government. Chweya has previously served as Permanent Secretary in the Office of the Vice President & Ministry of Home Affairs of the Republic of Kenya. He is presently on Leave of Absence from the University of Nairobi where he has supervised numerous graduate theses and lectured in International Relations, Security studies, and Political Economy of Development in the Department of Political Science & Public Administration for more than twenty years, rising to the position of Senior Lecturer. Prof. Chweya has recently been appointed Associate Professor of Political Science at the School.

Prof. Chweya has carried out numerous research works and published substantially in his field of specialization, written and presented papers in local and international conferences, provided consultancy services to governments and international organizations on a wide range of issues such as the African Peer Review Mechanism (APRM), the wider New Partnership for African Development (NEPAD), United Nations Assistance Mission in Somalia (UNSOM) on the re-establishment of the Somali civil service, and United Nations Development Program (UNDP) on Development of Benchmarks for Good Governance.

During his tenure in Government, Prof. Chweya spearheaded fundamental reforms in the Kenya Prisons Service, especially transforming inmate facilities from "prisons" to truly "rehabilitation homes." While at KSG he has led a team of staff to develop high level training curricula, research agenda, and consultancy programs that have been instrumental in transformation of the public service in Kenya and the region and raised the School's standing to international standards.

Prof. Chweya received the Bachelor of Arts (Hons) Degree and the Master of Arts degrees in Government from the University of Nairobi and the Doctor of Philosophy Degree in Political Studies from Queen's University at Kingston, Ontario, Canada.

Ms. Anni Haataja joined UN DESA in 2009 and is currently a Governance and Public Administration Officer in the Program Management and Capacity Development Unit of the Division for Public Institutions and Digital Government (DPIDG). Mr. Stephen Jackson (Ireland) has recently arrived as Resident Coordinator of the United Nations System in Kenya.
