This meeting will be devoted to questions relating to the training of public officials on the SDGs. At the eighteenth session of the Committee, many participants had expressed the wish to focus on the training of public officials as an essential component for the achievement of the SDGs. Here the emphasis is placed on the importance of both the initial and the ongoing training of public officials for the achievement of the Goals. Important questions arise regarding the Goals that should be the subject of such training, the target audiences, the potential content of the training, its structure and appropriate teaching methods and processes.

## Virtual meeting 4 – Thursday, 21 May 2020

## 8:30-10:30 a.m.Building institutions to promote peaceful and inclusive societies and provideNew York timeaccess to justice for all [item 8]

The establishment of a viable public administration is a key part of Statebuilding in the aftermath of conflict and of supporting long-term peacebuilding. At its seventeenth session, the Committee considered the question of stakeholder engagement in post-conflict countries. It concluded, inter alia, that re-establishing legitimacy and trust were challenges faced by post-conflict societies, where certain groups might have been systematically excluded and military, police and other institutions might be associated with repressive or corrupt practices. At its eighteenth session, the Committee expanded its consideration of the institutional aspects of SDG 16, with a discussion of the underlying issues in relation to promoting security and access to justice for all and ways to support the institution-building aims of Goal 16 in those areas.

This meeting will take the thinking forward with a discussion of the links between State-building with peacebuilding. Both require the rebuilding of trust in public institutions, which, in turn, warrants inclusionary post-conflict public administration reconstruction. The Committee will be invited to consider these questions, inter alia, from a post-pandemic context with a view to contributing to the work of the Peacebuilding Commission from a medium- to long-term perspective.

## Virtual meeting 5 – Wednesday, 27 May 2020

### **8:30-10:30** a.m. Emerging issues in public financial management and budgeting for the SDGs New York time [item 9]

As government budgets significantly influence people's lives and well-being while also providing opportunities to address societies' most pressing needs, transparent, inclusive and credible budgets become key policy objectives. Moreover, the achievement of the SDGs depends on the ability of Governments to execute budgets as intended and in line with national development objectives and needs. That said, opaque budget-making practices and unbalanced budget compositions, with underspending in sectors that may be critical to sustainable development and overspending in others, continue to plague public financial management systems. Such problems are exacerbated by limited opportunities for citizens to participate in budgeting, as well as other challenges, such as the limited capacity of oversight institutions to scrutinize budgets.

Better budgeting within the context of the 2030 Agenda means explicit and measurable presentation of Goal targets in budget allocations and reports, as well as in other elements of the budget cycle. Budgeting for the Goals as a practice is still in its infancy. Several countries have announced, through voluntary national reviews, the intention to reflect the Goals in budgetary processes but few have specified why it would be relevant to do so or how the practice could be made operational. This virtual meeting will consider the most important enablers of successful budgeting for the Goals and the critical role of stakeholders in budget-making practices.
