1. Background

The United Nations Department of Economic and Social Affairs (UN DESA) and the United Nations Economic and Social Commission for Western Asia (UN ESCWA) are co-organizing an Online Training Course on “Changing Mindsets and Strengthening Governance Capacities for Policy Coherence for a Holistic Implementation of the 2030 Agenda in the Arab region”. The Online Training Workshop will be held on 26 and 28 January and 2 and 4 February 2021 for 2 hours and 45 minutes each day (8:00 AM – 10:45 AM New York time).

The Facilitated Online Training Course aims at raising awareness and developing capacities among senior public officials from the Arab region on the need for effective institutional arrangements for holistic policy coherence to implement the 2030 Agenda for Sustainable Development. It also aims at highlighting the importance of changing mindsets and key competencies needed for effective policy coherence.

2. Thematic Focus

The Facilitated Online Training Course builds upon the Capacity Development Webinars on “Leveraging Public Governance & Exploring Innovative Solutions to Address the COVID-19 Pandemic in the Arab Region: Building better institutions, towards a brighter future” organized by UN ESCWA, UN DESA and UNESCO in June and July 2020.

The Capacity Development Webinars have highlighted that the Arab world faces an unprecedented challenge that could lead an already volatile region into complete relapse. 8.3 million people in the region are expected to fall into poverty because of COVID-19.

The pandemic affects in particular those Arab countries where years of conflict and unrest have destroyed the health infrastructure. At the same time, the pandemic has exacerbated institutional

vulnerabilities to address poverty and socio-economic challenges and lack of coordination among levels of government.

In various Arab countries, COVID-19 has highlighted the challenges faced by public institutions in dealing with the crisis. In some instances, measures were not taken seriously by the citizens and the health crisis was poorly handled. However, some other countries have managed, to a various extent, to leverage a comprehensive approach to tackle the pandemic by engaging and partnering with non-state actors, such as civil society organizations and the private sector. Other groups of countries – some of them in a conflict situation – took swift actions and responded very quickly. They were able to coordinate policy responses across government levels notwithstanding the institutional fragmentation and divisions. Successful countries in fighting COVID-19 had in place clear lines of authority and responsibilities and had strategic plans for responding both during the outbreaks and the recovery.

The crisis is undermining the achievement of all the SDGs by hitting all segments of the population, all sectors of the economy, and all regions of the world. Its impact has extremely affected the poor and the vulnerable and caused million job losses globally. Also, the effects of the pandemic and the measures taken to mitigate its impact have overwhelmed health systems globally¹.

Strengthening the capacities of government and their public servants is needed more than ever since national and local governments are at the frontline of addressing the pandemic. Policy coherence, collaborative leadership, strategic thinking and planning, evidence-based decision making, and enhanced partnerships with academia and the private sector are all critical measures that can help governments elaborate immediate responses to uplift the poor and the vulnerable and reduce inequalities, including the one in gender. Also, investing in data essential to respond to the crisis and accelerate SDG implementation.

Despite some progress prior to the pandemic, countries were not on track to achieve the Sustainable Development Goals (SDGs)². As the pandemic lingers on worldwide and poverty and unemployment are likely to increase in the aftermath of the pandemic, business as usual will no longer be sufficient to overcome the pandemic (crisis response) and build back in a sustainable manner. The multitude and complexity of issues having an impact simultaneously calls for transformational change and enhanced whole-of-government approaches through coordination across sectors and levels of government to ensure more inclusive, equitable and resilient societies. This requires, among other measures, capacity for organizing (government) institutions and other stakeholders engaged in SDG implementation to promote policy coherence. It also calls for strengthening public servants' capacity to implement the SDGs through the development of new mindsets, skills, and behaviours and through new ways of working together across organizational boundaries.

Developing policies on a short term to respond swiftly to the crisis, without considering the inter-generational effects, can run the risk of increasing the impacts of climate change (e.g., further water shortages), which in turn can potentially trigger conflict, and aggravate volatility and fragility. Coherent policies and effective institutional arrangements for coordination are essential to respond successfully to the challenges posed by the pandemic. A sustainable response will also require the re-configuration of social systems, new ways of thinking, and approaches that can lead to a new social contract where trust between citizens and public institutions can be enhanced.

3. Objectives

In embarking on a sustainable recovery from the pandemic, UN Member States have an opportunity to accelerate SDG implementation and implement the 11 principles of effective governance for sustainable development endorsed in 2018 by the United Nations Economic and Social Council (ECOSOC). One of the 11 principles is related to sound policymaking.

In line with the above, UN DESA is developing a Curriculum on Governance for the Sustainable Development Goals. The Curriculum contains a capacity development training-of-trainers toolkit on “Institutional Arrangements and Governance Capacities for Policy Coherence” and one on “Changing Mindsets in Public Institutions to Implement the SDGs”. The objective of the Training Course is to pilot test selected modules of the toolkits and provide hands-on activities to identify priorities and action plans on how to change mindsets and promote policy coherence.

More specifically, the Online Training Course aims to:

1. Sensitize senior public officials from the Arab region about the need for effective institutional arrangements for holistic policy coherence (e.g., to address water challenges and food security) as a vehicle for cooperation.
2. Promote awareness of the importance of changing mindsets for more effective coordination and collaboration.
3. Enhance knowledge about governance capacities for policy coherence and changing mindsets for sustainable development; planning and systems thinking; cross-governmental, and inter-ministerial collaboration, and multi-stakeholder engagement.
4. Identify key priorities and follow-up actions to promote policy coherence and changing mindsets in public institutions.
5. Receive feedback from the participants on the relevance of the toolkits to their national context.
6. Ascertain Member States’ demands for follow up capacity development on these issues at the national level.

4. Methodology and Session Themes

The Facilitated Online Training Course will feature presentations by experts, interactive activities, group discussions and innovative practices for peer-to-peer learning. It will focus on group discussions, which will enable participants to transform in-depth learning into practice.

The Online Training Course will be composed of four sessions:

Session 1 will focus on an overview of governance capacities needed for policy coherence and changing mindsets. It will include the following key elements:

1. Assessment of a country’s needs regarding institutional arrangements for policy coherence and changing mindsets (based on a pre-questionnaire).
2. Understanding of the building blocks for policy coherence and the importance of institutional arrangements.
3. Overview of the role of public institutions in changing mindsets and tackling the SDGs.
4. Understanding of the mindset shifts that should occur at multiple levels (individual, organizational and institutional) to promote policy coherence.

Session 2 will focus on planning and systems thinking. It will include the following:

1. Discussion among participating countries about policy priorities, linking them to system thinking and discussion about the importance of politics in the policy cycle.

2. Discussion about the importance of long-term planning and system thinking: the need to develop, plan and monitor policies in an integrated manner.
3. Understanding the importance of an experimental and strategic mindsets to implement the SDGs and realize the principles of the Agenda 2030.

Session 3 will focus on cross-governmental and inter-ministerial collaboration. It will include the following elements:

1. The importance of different types of mindsets needed for collaboration.
2. Peer-to-peer learning among countries that have promoted policy coherence through a round-table discussion on institutional arrangements for policy coherence and changing mindsets.

Session 4 will focus on multi-stakeholder engagement. It will include the following elements:

1. Discussion of the gaps, challenges and strategies of multi-stakeholder engagement (based on the readiness assessment)
2. Activity on changing mindsets
3. Action planning as a take-away and a trigger to proceed upon completion of the Online Training Course.

For each session and between sessions, participants will undertake pre-webinar assignments individually and/or in country teams.

5. Format

The Facilitated Online Training Course will be composed of four webinars that will each run for two hours and forty-five minutes. Discussions during the meeting will adhere to the Chatham House Rules. The follow-up actions, including key recommendations and the summary of the discussion, will be disseminated through the UN DESA and UN ESCWA websites.

The Training will be conducted in English, through the online platform Zoom. Breakout group discussions can be conducted in Arabic and French.

Participants should commit to participating in all four sessions as they are inter-connected and build on each other.

6. Target Audience

Senior public officials, including policy makers, heads of planning departments, coordinators for the implementation of the SDGs or for the implementation of national development plans, ministry of finance, chief innovation or information officers, parliamentarians, and schools of public administration, among others.

Participating countries: Bahrain, Morocco and Oman

7. Expected Results

The Online Training Course will promote critical understanding of sustainable development issues, enhance governance capacity, strengthen public servants' awareness of their active role in contributing to the achievement of the SDGs and develop the knowledge and capacities required to

promote policy coherence to implement the 2030 Agenda for Sustainable Development. The piloting of the toolkits intends to support concrete outcomes and lasting impact.
