Sustainability at the heart of city planning

- Policies are designed with sustainability in mind and geared towards accomplishing the 17 SDGs.
- Singapore is ranked the fourth most sustainable city in the world, and first in Asia (Arcadis' 2018 Sustainable Cities Index) – People, Planet and Profit.



Sustainability at the heart of city planning

- Key Principles for sustainable development
 - 1. Long-term **planning**
 - 2. In-depth **understanding of unique circumstances & vulnerabilities** (e.g. lack of natural resources)
 - 3. Listening to **needs** (citizen-centric policies)
 - 4. Coherent, integrated policies & objectives across the Government
 - 5. Embracing change through **flexibility & innovation**
 - 6. Being **dynamic** to foresee and adapt to future challenges

Inter-Ministry Committee on SDGs (IMC-SDGs)

- Sustainable development guides our Whole-of-Government (WOG) approach to policy-making.
- An Inter-Ministry Committee on SDGs (IMC-SDGs) co-chaired by the Ministry of Foreign Affairs (MFA) and Ministry of Sustainability and the Environment (MSE) coordinates SDG-related efforts across a broad range of Ministries and Statutory Boards.
 - Efforts supported by Department of Statistics, our national statistical office.

IMC-SDGs: First Voluntary National Review (VNR)

- First VNR at the 2018 High Level Political Forum (HLPF) to review SDG implementation
- 3 tiered approach
 - 1. Internal stocktake of our current progress on the SDGs
 - 2. Consultative and iterative process in producing the VNR report with agencies
 - 3. Outreach to non-governmental stakeholders to adopt a Whole-of-Nation approach

Follow-up and Monitoring of SDG Progress

- Exploring ways to strengthen institutional mechanisms for SDG implementation, improve stakeholder consultations and strengthen data collection, availability and monitoring of progress.
- Singapore's Department of Statistics (DOS) works with IMC-SDGs and relevant government agencies in collating SDG data and shares our findings and progress on SDG implementation at key international and regional fora
 - → Chair of the ASEAN Working Group on Sustainable Development Goals Indicators (2020-2021) – ASEAN SDG Indicators Baseline Report 2020

Monitoring SDG Progress – SDG Webpage

- In Sept 2019, Singapore's Department of Statistics launched a SDG webpage which tracks Singapore's progress according to the SDG indicators.
- Currently exploring ways to streamline data collection and monitoring efforts through a broad-ranging inter-agency effort.
- Ensuring that the data is meaningful to Singapore's unique context, since countries have **flexibility** and can develop their own reporting formats, frameworks, and proxy indicators for SDG reporting.


