Chief Advisor and International Affairs Coordinator, Mexico City Government







Dr. Alarcon recently served as Head of the Policy and Development Analysis Unit at the United Nations Department of Economic and Social Affairs (UN DESA). From this position, she led the editorial team of the World Economic and Social Survey, the world's largest publication on development data. In the United Nations Secretariat, she played a leading role in the

preparation of analytical contributions to the intergovernmental processes that defined the 2030 Agenda for Sustainable Development. Dr. Alarcon played an important role in the coordination of technical assistance provided by the United Nations for the implementation of the Millennium Development Goals (MDGs); she was co-chairman of the United Nations commission that prepared the meta-data for the MDGs, and in 2008 she co-directed the creation and annual publication of the report on compliance with MDG-8 in relation to international cooperation for development. She worked for 10 years at the Inter-American Development Bank (IDB), as well as in the United Nations Development Program (UNDP) and the International Labor Organization (ILO). Dr. Alarcon received PhD in Economics from the University of California, Riverside. Jesper has a long track-record of working with ambitious governments, public organisations and international institutions - in all parts of the world – to deliver better outcomes and systems transformation. Within States of Change, Jesper has been leading multiple

strategic partnerships – including the governments of Canada, Colombia, UAE and Australia and international institutions such as UNDP, NATO and the EU Commission. Louis Meuleman works at the European Commission in Brussels as coordinator of the Environmental Implementation Review and of the greening of the European Union's economic and social governance. He is visiting professor at the Public Governance Institute of the University of Leuven, in Belgium, senior fellow at the Center for Governance and Sustainability of the University of Massachusetts, in Boston, United States of America, research associate at the University of Wageningen, in the Netherlands, and member of the editorial board of Impact Assessment and Project Appraisal. He is a member of the International Association for Impact Assessment, the European

Sustainable Development Network and the Netherlands Association for Public Management. He has 35 years of public sector management experience, handling subnational, national, regional and international issues, mainly in the fields of the environment and sustainable development, as project, programme and line manager. As director of the TransGov project of the Institute for Advanced Sustainability Studies in Potsdam, Germany, from 2010 to 2011, he produced the report entitled Transgovernance: the Quest for Sustainability Governance and was editor of Transgovernance: Advancing Sustainability Governance (2013. Mr. Meuleman has authored a number of publications, including his PhD dissertation, Public Management and the Metagovernance of Hierarchies, Networks and Markets (2008). He was co-editor of Environmental Governance in Europe (2003). He has published books, book chapters and articles on environmental policy, interactive policymaking, meta-governance, governance of long-term decision-making, cultural diversity and sustainability governance. He has a PhD in public administration and an MSc in environmental biology.

Chief Specialist (Sustainable Development) in the Prime Minister's Office and Deputy Secretary General for the Finnish National Commission on Sustainable Development, Finnish Prime Minister's Office



Marja Innanen is a Chief Specialist (Sustainable Development) in the Prime Minister's Office. She also works as Deputy Secretary General for the Finnish National Commission on Sustainable Development, which is led by the Prime Minister. Marja Innanen and the general secretariat for Sustainable development work for to engage the whole of Society and the whole of the Government in implementation of the 2030 Agenda for Sustainable Development. She has been involved in all the latest phases during implementation of the 2030 Agenda in Finland, eg. the Government's

implementation plans (2017, 2020), the National Voluntary Report of Finland (HLPF 2016, 2020), the follow up and monitoring system, the state budgeting process of the 2030 Agenda, the National SD Strategy, and the evaluation process. Before working in the Prime Minister's office for the past three years, she worked for over 18 years with various environmental and sustainability topics in the Ministry of Environment, Ministry of Agriculture and Forestry, WWF Finland, Finnish Environment Institute and a private environmental consultant agency.

Rolf Alter (Germany)

Senior Fellow, Hertie School of Governance



Dr. Rolf Alter is an experienced economist and Senior Fellow at the Hertie School. He is also a member of the Advisory Board of the World Economic Forum Global Risk Report. He spent over 25 years at the Organisation for Economic Co-operation and Development in Paris. In 2006, he was appointed Chief of Staff to the OECD Secretary-General, and in 2009 he became Director of Public Governance. Alter built a team of over 200 staff to support governments in improving their public sector performance for inclusive growth and economic competitiveness. He previously also worked for the IMF in Washington, DC, and for the German Ministry of Economy in Bonn. For the

last several years, he has been a member of the Advisory Board of the Global Risks Report of the World Economic Forum. Dr. Alter's interests include institutional and regulatory reform, productivity, innovation, results-oriented budgeting, transparency, leadership and integrity. He holds a doctorate from the University of Göttingen. In 2013, he received a doctorate h.c. from the National University of Hungary and in 2016 was awarded the O.P. Dwivedi Award by the International Association of Schools and Institutes of Administration for his outstanding contribution to public administration and policy.

(with Sylvia Veit), the leading German-speaking journal in public administration and public policy. Before joining the Hertie School, she was a Visiting Professor at Freie Universität Berlin and a postdoctoral researcher at Potsdam University with research visits at the University of Bergen (Norway) and the University of Toronto (Canada). Dr. Adriana Alberti is Chief, Programme Management and Capacity Development Unit, Division for Public Institutions and Digital Government, UN DESA. She has thirty years of international knowledge and expertise in governance and public administration. She coordinated and contributed to a number of UN publications, including the UN E-Government Survey. Chairman and Executive Director, Bangladesh Institute for Information literacy and Sustainable Development (BILLSD)



Dr. Alam had been a career civil servant with the Bangladesh Administrative Service. He has recently retired as a Senior Secretary to the Government. He has been a catalyst in the public service capacity development for SDGs as Rectors of Bangladesh Public Administration Training Centre (BPATC) and Bangladesh Civil Service Administration Academy. He has been a Vice President of the Bangladesh Society for Training and Development (BSTD) for over a decade. He has significantly contributed to the development policy making in his role as the Secretary, Financial Institutions Division (FID) of the Ministry of Finance, Government of Bangladesh and the Secretary of the

Ministry of Disaster Management and Relief (MoDMR) as well as the Director General of the Department of Land Records and Surveys and the Director General-3 at the Prime Minister's Office. He also worked on lien with the UNDP/UNOPS for four years as the Senior Program Manager of the Comprehensive Disaster Management Programme (CDMP). Dr. Alam has been a catalyst in the digitalization of special libraries at the governmental level. He is playing a pioneering role in the information literacy movement in Bangladesh as well as awareness making for the 4th industrial revolution. Karam Karam is Regional Advisor on governance, peacebuilding and transitions at United Nations Economic and Social Commission for Western Asia (UN-ESCWA). Before joining ESCWA, He worked as Head of Research at the Common Space Initiative (CSI-UNDP). He supervised national and regional research and mapping related to the national dialogues and reform processes in the MENA region. He also supported and facilitated a number of national dialogue processes. Mr. Karam was an associate professor at the Faculty of Law and Political Science at the Lebanese University. Senior Interregional Advisor Governance and Public Institutions, United Nations Department of Economic and Social Affairs



Veronique Verbruggen is Senior Interregional Advisor for Governance and Institution Building and supports the UN member states (in particular LICs, SIDS and Land locked developing countries) with the implementation of SDG 16 as part of the Sustainable Development Goals framework, more in particular in the area of institutional and policy coherence and public sector reform. She was deployed as Senior Political Affairs Officer at UNSOM (Somalia) on matters of stabilization, community recovery, local governance and service delivery and peacebuilding matters. She worked for 13 years as Senior Governance and Conflict Advisor in Kenya, Russia/ North Caucasus,

Ukraine, the Western Balkans, Iraq, Afghanistan, Turkey and Indonesia on behalf of the British Department for International Development (DFID). As Public Sector Governance Reform specialist to the European Commission's DG for Enlargement she led a public sector reform strategy in partnership with OECD that was implemented in collaboration with North Macedonia, Croatia, Serbia, Albania, Bosnia & Herzegovina, Turkey and Kosovo. As Chief Program and Knowledge Management at the UNDP- hosted Commission on Legal Empowerment of the Poor, she shaped and implemented roadmaps to give people operating in the informal economy access to justice, strengthen labor and business rights and strengthen secure tenure of land. Youness Abouyoub (Lebanon)

Chief of Governance and State-Building Section, United Nations Economic and Social Commission for Western Asia (UN-ESCWA)



Dr. Youness Abouyoub is the Chief of Governance and State-Building Section at the United Nations Economic and Social Commission for Western Asia (UN-ESCWA). He is in charge of a diverse portfolio of programmes on governance and institutional development that provides member States with substantive analysis, policy advice, technical assistance, capacity-building and knowledge sharing on a host of governance and institutional matters, including political reform and transition, crisis and conflict management, and damage and loss assessment. This holistic approach stresses the importance of laying the foundations for accountable, responsive and inclusive governance institutions, as well as crisis management and post-conflict institutional rehabilitation. These programmes also focus on consensus-building and national dialogue efforts,

and international and regional governance cooperation. Dr. Youness Abouyoub, leads the publication of the Arab Governance Report and the work of ESCWA on governance and conflict prevention, which is linked to efforts to help member States to develop transparent, accountable, inclusive and effective public sector institutions and, in so doing, to improve core Government services. It shares best practices, particularly with crisis-hit and post-conflict countries, and LDCs, and runs innovative technical cooperation projects designed to bolster the capacity of Governments to respond to emerging crises.
